The Department of Public Works and Infrastructure (DPWI) is committed to ensuring the highest standards of health, safety, and regulatory compliance on all its construction projects. In response to the critical need for enhanced safety practices and strict adherence to national legislation, this specification outlines the requirement for a training programme on the Construction Regulations.

The purpose of this training is to equip DPWI officials with the mandatory knowledge and practical skills to implement and enforce the Occupational Health and Safety Act (85 of 1993) and its incorporated Construction Regulations of 2014.

The training must empower officials to understand their legal duties, ensure project compliance and ultimately contribute to reducing incidents and losses on DPWI construction sites.

2. LEARNING OUTCOMES

Upon successful completion of this course, delegates must be able to:

- Interpret and apply the legal requirements of the OHS Act and the Construction Regulations 2014 in a project environment.


