## **SPECIFICATION FOR SOURCING A SERVICE PROVIDER: MINUTES TAKING AND REPORT WRITING COURSE**

### **1. Purpose**

The purpose is to appoint an accredited training provider to facilitate a Minutes Taking and Report Writing course for Department Public Works and Infrastructure, Cape Town Regional Office officials.

### **2. Background**

Minutes Taking and Report Writing is one of the critical aspects of any organisation. It offers an opportunity to improve writing skills, communicate effectively, build healthy business relationships and become more productive. The course is for officials engaged in office administrative or support-related activities Administrators, Secretaries and Supervisors. A total of 25 officials will be attending the training.

### **3. Learning Objectives**

By the end of this training course, participants will be able to:

- To learn the value of good written communications;
- Understand how to write with clarity, brevity and a modern, professional voice;
- Communicate complex information, ideas, decisions and arguments to a variety of readers, using clear language;
- Write well-structured documents that get the message across quickly, clearly and effectively;
- To prepare reports and proposals that inform, persuade, and provide information;
- To learn how to proofread your work so you are confident it is clear, concise, complete, and correct;
- Identify and avoid common errors in grammar, sentence structure, vocabulary and punctuation;
- Improve the presentation of a report;
- Have the skills to edit and proofread your own and others' written work;

3.1 The course must be set at a minimum NQF level 4 Unit Standard. On completion of the course, course delegates will receive certificates of completion.

3.2 It is a requirement that all service providers facilitating any training must be accredited with a SETA or Quality Council for Trades and Occupations (QCTO) body and must have a valid letter confirming such accreditation.



#### **4. Training Methodology, Delivery and Duration**

Training methodology must include a combination of both theoretical and practical approaches. The course will be delivered through a face-to-face classroom setup with appropriate case studies and practical exercises. A successful training provider must provide a training venue in Cape Town with catering, learning material, computer resources and online access. The course duration is two (02) days of class time for 25 officials.

#### **5. Training Provider Checklist:**

The following requirements are compulsory and must be attached as proof of accreditation and experience:

- A valid letter of accreditation as a training provider with a SETA or QCTO;
- A comprehensive CV showing the facilitator's subject matter expertise in data and records management;
