Overview and Purpose

The National Department of Public Works and Infrastructure (NDPWI), Cape Town Regional Office is searching for a service provider to conduct a conflict management intervention targeted at improving working relations and team performance.

Background of the DPWI Regional Office

The NDPWI is legislatively mandated as the custodian of a significant portion of the National Government's immovable assets. To deliver on this mandate, the Department performs a wide range of activities including the management of a large portfolio of infrastructure projects. The effective management of the projects is complex and requires the deployment of competent officials.

Scope of Work

A service provider shall conduct the following exercises:

- 1. One (1) day pre-briefing session with two conflicting individuals. This takes place before the workshop.
- 2. One (1) day pre-briefing session for the group (32 officials) audit/ emotional impact assessment: Analyse the current team dynamics and identify the sources of conflict and impediments to team performance.
- 3. Two (2) days of training facilitation on conflict management focusing on leadership empowerment and group alignment to strengthen relationships and improve collaboration for a total of 36 officials.

Submit a detailed proposal that includes the approach, timelines, and financial implications. Also, each deliverable must be quoted with the total amount for the project at the end. Use the pricing schedule provided.

A service provider must provide a suitable venue with catering and include the necessary resources to achieve the objectives of the training. The training session will be conducted over 2 days. Dates will be finalised in consultation with the successful service provider.




