APPOINTMENT OF SERVICE PROVIDER TO FACILITATE A BID COMMITTEES COURSE

1. Purpose

The purpose is to appoint an accredited training provider to facilitate a Bid Committees training for the Department of Public Works and Infrastructure, Cape Town Regional Office officials.

2. Background

2.1 The Department is required to conduct the PFMA Bid Committees training on an ongoing basis for all serving members of the Bid Committees for Specification, Evaluation, Adjudication and including Project Leaders as well as SCM officials who play a role and responsibilities to support the functioning of the Committees.

2.2 The duties and responsibilities of the serving committee members must be aligned with the basic values and principles governing Public Administration as contained in the Constitution of the Republic of South Africa, in that it promotes a high standard of professional ethics, the efficient, economic, and effective use of resources and accountability.

2.4 To comply with the SCM Policy and PFMA, the Department must ensure that all Bid Committee members are capacitated to ensure they discharge their responsibilities effectively and efficiently.

3. Expected Outcomes/ Deliverables

By the end of this course, delegates will be able to:

- Explain the elements of the Supply Chain Management model within public service that applies to the bid committee system to establish the Supply Chain Management context;
- Explain the Regulatory Framework that governs Supply Chain Management within the public service to demonstrate an understanding of how each legislation or prescript regulates the decision-making of bid committees;
- Discuss the importance of ethical conduct for Supply Chain Management practitioners within the Public Service and how this impacts on bid committee member behaviour;
- Prepare a bid or quotation invitation for a specific commodity within the public service, according to National Treasury Regulations and Practice Notes a fair, transparent and equitable bid invitation;
- Evaluate bids or quotations and compile written recommendations to the Bid Adjudication Committee for approval;
- Adjudication of bids, based on recommendations from the Evaluation Committee in line with fairness, correctness and compliance against

predetermined bid criteria or the drawing up of a resolution to the relevant authorities for the award of the bid to a provider;

- Delegations, roles and functions of the Bid Specification Committee, Bid Evaluation Committee and Bid Adjudication Committee;
- Bid Committee procedures
- Use of scenarios for actual practical examples on evaluation and adjudication

4. Training Methodology, Delivery and Duration

4.1 In total, **100 officials** will be attending the training. At the end of the workshop, course delegates will be awarded Certificates of Attendance.

4.2 Facilitated will be conducted via an in person classroom set up, and it must include a combination of both theoretical and practical approaches. A successful training provider will provide a training venue inclusive of catering, learning material and connectivity.

4.3 **There will be three (3) separate classes each with 33 delegates attending over 3 days.** Training dates will be determined collectively with the successful training provider and the course coordinator.
