2.2 Ordering

- Suppliers must be able to receive and respond to a request for quotation through email within 24 hours during working hours (08:00 – 15:00, Monday – Friday, excluding public holidays).
- On confirmation of the quote and stock availability, NDPWI will issue an order.
- Purchase orders will be placed with Supplier from time to time as and when goods are required.
- NDPWI reserves the right to place purchase orders until the last day of the contract for deliveries to be effected within the delivery period/ lead time specified beyond the expiry date of the contract under the same terms and conditions as agreed upon.
