#### 1. INTRODUCTION

The National Dept. of Public Works and Infrastructure (NDPWI) invites quotations for the supply of various skips to various sites and the removal of the waste.

#### 2. DELIVERY PERIOD

- The contract period will be on services as per the pricing schedule and will commence on receipt of an official order for a **duration of 3 months**. The successful bidder shall comply with the time frames in terms of delivery and collection.
