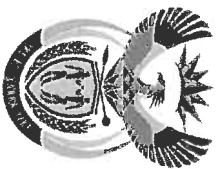

The National Dept. of Public Works and Infrastructure (NDPWI) invites quotations for the supply of various lid covered skips to various sites and the removal of the waste.

2. DELIVERY PERIOD
