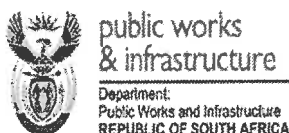

1. INTRODUCTION

The National Dept. of Public Works and Infrastructure (NDPWI) invites quotations for the supply of various skips to various sites and the removal of the waste.

2. DELIVERY PERIOD

The contract period will be on services as per the pricing schedule. It will only commence on the receipt of an official purchase order for a **duration of 2 months and NO longer**. The successful bidder shall comply with the time frames in terms of delivery and collection.

3. SUBMISSION REQUIREMENTS
