### 1. INVITATION

- 1.1 The Department of Public Works and Infrastructure, Cape Town Regional Office intends to appoint a service provider with relevant experience to provide the following services.

### 2. SCOPE OF THE REQUIRED SERVICE

- 2.1 The successful bidder will be expected to supply and deliver the following:

- 2.1.1 Supply, delivery, installation of automated hand sanitizer units in various buildings and automated hand soap dispensers in bathrooms.
- 2.1.2 Monthly servicing and refilling of automated hand sanitizers.

4.4 All products must be delivered in a clean and hygienic delivery transport.

## 5 SPECIAL CONDITIONS

5.1 Should the Supplier fail to deliver in the required timeframe, the Department reserve the right to source items from other service providers and recover any difference in cost from the appointed service provider.

5.2 In case of emergency procurement, service provider should be able to deliver within 24 hours (between 07h30 -16h00-business hours) from receipt of an official purchase.

5.3 Government Procurement General Conditions of contract (GCC) as issued by National Treasury will be applicable on all instances.

## 6 Basis of Contract

6.1 The general condition of contract of contract (2010 version, issued by National Treasury) as supplemented by terms and condition set out in the terms of reference, shall constitute the basis of the contract between the parties.

6.2 In the event of contradiction between the two documents the Terms of Reference shall prevail.

## 7 PRICING GUIDELINE AND SCHEDULE
