1. INVITATION

1.1 The National Department of Public Works and Infrastructure (NDPWI), Cape Town Regional Office intends to appoint a service provider to supply and deliver Toilet Paper and Hand Paper towels (Once off).

2. SCOPE OF THE REQUIRED SERVICE

2.1 The successful bidder will be expected to supply and deliver the following:

2.1.1 The hand paper towels and toilet paper must be in accordance with the specifications in the table below.
