- 3.2 Should the Supplier fail to deliver in the required timeframe, the Department reserve the right to source items from other service providers and recover any difference in cost from the appointed service provider.

4. BASIS OF CONTRACT

- 4.1 The general condition of contract of contract (2010 version, issued by National Treasury) as supplemented by terms and condition set out in the terms of reference, shall constitute the basis of the contract between the parties.
- 4.2 In the event of contradiction between the two documents Terms of Reference shall prevail.

5. PRICING SCHEDULE

Notes to Pricing:

- Prices must be quoted in South African Rand.
- Bidders must quote for all items [cleaning material] or the Bid will be deemed non responsive.

6. PRICING
