TERMS OF REFERENCE

1. INVITATION

The Department of Public Works and Infrastructure, Cape Town Regional Office intends to appoint a service provider with relevant experience to supply and deliver cleaning material.

2. PROJECT DELIVERABLES

2.1 Delivery and distribution

2.2 Ordering

- Suppliers must be able to receive and respond to a request for quotation through email within 24 hours during working hours (08:00 – 15:00, Monday – Friday, excluding public holidays).
- On confirmation of the quote and stock availability, NDPWI will issue an order.
- Purchase orders will be placed with Supplier from time to time as and when goods are required.
