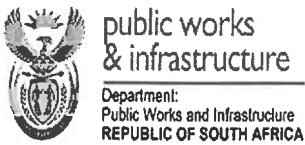

#### 1. INTRODUCTION

The National Dept. of Public Works and Infrastructure (NDPWI) invites quotations for the supply of various lid covered skips to various sites and the removal of abattoir waste.

#### 2. DELIVERY PERIOD

- The contract period will be on services as per the pricing schedule and will commence on receipt of an official order on a month-to-month basis until **31 July 2026**. The successful bidder shall comply with the time frames in terms of delivery and collection.
- Total number of services over the period equals 79 services.

#### 3. SUBMISSION REQUIERMENTS
