Restoration work on chairs/ sofas;

Outer woodwork- frame: arms, front and back leg, side stretchers and front stretcher;

The wood needs to be cleaned by scrubbing up the wood surfaces, if all the stages of cleaning and the process of polishing the wood with oil-based commercial wood cleaner etc. do not bring the wood back to its original look, then the chairs need to be completely restored.

Fix the cracks with glue or screw back the loose/ broken arms and legs.

Restoration means; buffing out the imperfections or stripping the old finish and making room for new stains.

Insulation layers- Foam, Tempered steel springs, Dacron;

The chairs must be striped to evaluate the amount of damage in the insulation layers, if the foam is not firm then it will need to be replaced, as well as every layer that is damaged, and put new Dacron.
