 - 2.1.2. **ID copies and a company profile must be forwarded to access the site, minimum two (2) days before the preferred date.**
 - 2.1.3. **This is required to enable SAPS to conduct a security screening for the issuing of day-pass access permit to the site.**

3. Failure to submit a copy of the ID document, company profile and request letter will result in SAPS/ Permit Office not granting access to Pelican Park and Ministerial Residence, as the properties requires access permits.
