1. LOCATION OF SERVICES TO BE RENDERED

2. SCOPE OF SERVICE

2.1 This scope of work applies to all the Magistrate Courts mentioned in Table 1.1.

2.2.1 Plant beds

- Remove all paper, plastic, tins and undesired objects from the plant beds and in and around tree.
- Cultivate all plant beds, lawns, including courts yards and open plots forming part of the erf.

2.2.2 Weeding

- Remove all weeds from plant beds, tree rings, planter boxes and pots.
- Climber plants growing into and onto tree and walls must be removed.

2.2.3 Pruning

- Dead head flower heads in plant beds at each service.
- Keep all climbers pruned back from trees and walls.

- Trim all lawn edges as lawn mowing takes place.
- Edge trimming must also be performed on the fence line onto hard surfaces.

2.2.5 Hard surfaces

- All hard surfaces to be free of weeds and algae.
- The appropriate herbicide and algaecides must be used or manual cleaning must be applied.

2.2.6 Watering

- Watering of plant beds, planters, court yards and lawns must take place with each service, unless instructed differently by the designated DPW&I official.

2.3 TERMS AND SCHEDULE

- The term of this agreement will commence on the date the successful bidder is appointed and will expire when all services have been rendered on or before the 31 March 2025, whichever comes first.
- Service will be rendered on a Month to Month according to the department's discretion and can be terminated with a notice period of 30 days.
- The project manager will provide a work schedule to the successful bidder defining time lines for this project.

3. GENERAL CONDITIONS

- 3.1 The service provider must sign in with the security present on the day as they enter the premises before performing the service, as well as sign out as they depart the premises.
- 3.2 Every invoice needs to be accompanied by a signed confirmation of service from the office manager or court manager attesting to the quality of the work performed.
- 3.3 The bidder must provide all materials, manpower, and equipment deemed required for the services to be rendered.
- 3.4 Supervisors with appropriate horticultural knowledge must always oversee personnel.
- 3.5 Personnel may not enter places that are not work-related.
- 3.6 The Service provider need to be aware that the services they provide need to strictly adhere to the specifications.
- 3.7 The bidder may visit the sites in table 1.1 to satisfy him/herself with the extent in area and conditions of the property.
- 3.8 The service provider is accountable for any damages of moveable or immovable assets, made by them, on the premises and as such will be given 10 days to effect the repairs or replacement of the damaged items.

- 3.9 NDPW & Horticulture maintains the right to inspect the appointed service provider's equipment, machinery, and personal protective equipment (PPE).

4. OBSERVANCE OF LAWS AND REGULATIONS

4.1 Observance of Laws and Regulations

- 4.1.1 The service provider must secure all permits and licenses imposed by law and ordinance (e.g., controlled burn permits), pay all charges and fees, and give all notices necessary incidental to the due and lawful prosecution of the work regarding the obstruction of streets and driveways, maintaining signals and open passageways and protecting the same where exposed and controlled fires.
- 4.1.1.1 **Hours of Work:** The service provider must perform the work during weekdays and within operating hours 07:30 till 16:00 unless requested by a Departmental official to deviate.
- 4.1.1.2 **Equipment:** The service provider is responsible for providing, maintaining & transporting all necessary equipment in connection with the program of plot clearing and fire break creation and maintenance described in this Agreement. All other tools and supplies necessary for performing the work required by this Agreement will be provided by the service provider.
- 4.1.1.3 **Obstruction of Streets and Right-of-Ways:** The service provider will arrange to keep sidewalks open for traffic whenever possible and will block portions of streets only when deemed necessary to protect private property. Warning signs and barricades must be furnished and erected by the service provider when warranted. It is the service provider's responsibility to remove all surplus material and debris from streets as work progresses in order that the public to have adequate use of the affected streets.
- 4.1.1.4 The service provider must have in its employ, or under its control, sufficient qualified and competent personnel to perform work promptly and in accordance with a schedule or work program, as approved by the Departmental official.
- 4.1.1.5 The service provider must employ only such workers as are skilled in the tasks to which they are assigned. Workers shall act appropriately and professionally at all times. Offensive language, gestures or actions while in this facility are not acceptable. The Department may require the service provider not to assign any employee the Department deems incompetent, careless, insubordinate, or otherwise objectionable to work on these premises.

4.2 SAFETY STANDARDS

- 4.2.1 The service provider's employees must follow all applicable safety standards including operating all equipment in conformance with the manufacturer's operating instructions for each, and in compliance with OHSA standards and requirements.
- 4.2.2 Precaution be exercised at all times for the protection of persons, (including employees) and property. The safety provisions of applicable laws, building and construction codes must be observed. Machinery, equipment and all hazards must be guarded or eliminated in accordance with applicable safety provisions.

5. SITE INSPECTION

- 5.1 The Department official will, at their discretion, conduct site inspections before, during, and after each service to evaluate the quality, and completion of the work performed.

6 BASIS OF CONTRACT

- 6.1 The general condition of contract of contract (2010 version, issued by National Treasury) as supplemented by terms and condition set out in the terms of reference, shall constitute the basis of the contract between the parties.

7 BILLING AND PAYMENT TERMS

- 7.1 Billing will be processed per individual site as provided by NDPWI per the pricing schedule.
- 7.2 The order number, banking details etc. and account number must appear on all invoices and statements.
- 7.3 NDPWI invoicing and payment terms shall be in accordance with NDPWI Standard Terms and Conditions of Contract.
