## SPECIFICATIONS FOR SUPPLY, INSTALLATION AND MAINTENANCE OF ARTIFICIAL GRASS – PARLIAMENTARY DOME

### 1. LOCATION OF SERVICES TO BE RENDERED

1.1 Parliamentary Dome, Neiwemeister Parking

### 2. SCOPE OF SERVICE

#### 2.1 Preparation

2.1.1 **Surface preparation:** Sweep surface areas and wash only if necessary, letting it dry completely.

2.1.2 **Surface levelling for the internal area (inside the structure):** Fill cracks and uneven surfaces to ensure the surface is level as possible.

2.1.3 **Drainage and surface levelling for external area (outside the structure):** Ensure the various surface levels are even, with water drainage gradient in a south easterly direction away from the structure.

2.1.4 **Artificial grass acclimation:** Roll out the artificial grass in the sun or warm area to relax and expand the material making it easier to cut and fit.

#### 2.2 Installation

2.2.1 **Laying the artificial grass for the internal area (inside the structure):** Roll out the artificial grass onto the prepared surface aligning fibres in the same direction.

2.2.2 **Laying artificial grass for external area (outside the structure):** install drainage mats over the prepared surface. Roll out the artificial grass onto the prepared surface aligning fibres in the same direction.

2.2.3 **Cut, fit and seam joints:** Cut and fit the grass rolls as required to cover the surfaces. At the seam joints use seaming tape and the applicable adhesive under the grass edges, pressing firmly to secure the edges.

2.2.4 **Perimeter:** Apply a strong outdoor adhesive to all perimeter edges, ensuring the perimeter edges are secured to the surface.



## 2.3 Finishing

2.3.1 **Infill:** Spread silica sand evenly over the grassed surfaces. Brush in with a power broom or stiff bristled brush to work the sand into the base of the fibres.

## 2.4 Maintenance

2.4.1 Lightly hose down the artificial grass to wash away dust and light spills and let dry completely.

2.4.2 Infill with silica sand, if necessary.

2.4.3 Brush the fibres against the grain with a medium soft bristled broom or power brush to prevent matting.

## 3. GENERAL CONDITIONS

3.1 The preferred service provider must sign in with the security present on the day as they enter the premises before performing the service, as well as sign out as they depart the premises.

3.2 **This project will commence once the preferred bidder receives an official order from the Department, from which time the entire installation must be completed by the 10<sup>th</sup> February 2026 at 16h00.**

3.2 The bidder must provide all materials, manpower, and equipment deemed required for the services to be rendered.

3.4 Supervisors with appropriate knowledge to this project must always oversee personnel.

3.5 Personnel may not enter places that are not work-related.

3.6 The preferred service provider needs to be aware that the services they provide must adhere to the specifications.

3.8 The service provider is accountable for any damages of moveable or immovable assets, made by them, on the premises and as such will be given 10 days to effect the repairs or replacement of the damaged items.

3.9 NDPW & I horticulture maintains the right to inspect the appointed service provider's equipment, machinery, and personal protective equipment (PPE).

## 4. OBSERVANCE OF LAWS AND REGULATIONS

### 4.1 Observance of Laws and Regulations

4.1.1 The service provider must secure all permits and licenses imposed by law and ordinance (e.g., controlled burn permits), pay all charges and fees, and give all notices necessary incidental to the due and lawful prosecution of the work regarding the obstruction of streets and driveways, maintaining signals and



open passageways and protecting the same where exposed and controlled fires.

- 4.1.1.1 **Hours of Work:** The service provider must perform the work during weekdays and within operating hours 07:30 till 16:00 unless requested by a Departmental official to deviate.
- 4.1.1.2 **Equipment:** The service provider is responsible for providing, maintaining & transporting all necessary equipment in connection with the project of artificial grass installation described in this Agreement. All other tools and supplies necessary for performing the work required by this Agreement will be provided by the service provider.
- 4.1.1.3 **Obstruction of Streets and Right-of-Ways:** The service provider will arrange to keep sidewalks open for traffic whenever possible and will block portions of streets only when deemed necessary to protect private property. Warning signs and barricades must be furnished and erected by the service provider when warranted. It is the service provider's responsibility to remove all surplus material and debris from streets as work progresses in order that the public to have adequate use of the affected streets.
- 4.1.1.4 The service provider must have in its employ, or under its control, sufficient qualified and competent personnel to perform work promptly and in accordance with a schedule or work program, as approved by the Departmental official.
- 4.1.1.5 The service provider must employ only such workers as are skilled in the tasks to which they are assigned. Workers shall act appropriately and professionally at all times. Offensive language, gestures or actions while in this facility are not acceptable. The Department may require the service provider not to assign any employee the Department deems incompetent, careless, insubordinate, or otherwise objectionable to work on these premises.

## 4.2 SAFETY STANDARDS

- 4.2.1 The service provider's employees must follow all applicable safety standards including operating all equipment in conformance with the manufacturer's operating instructions for each, and in compliance with OHSA standards and requirements.
- 4.2.2 Precaution be exercised at all times for the protection of persons, (including employees) and property. The safety provisions of applicable laws, building and construction codes must be observed. Machinery, equipment and all hazards must be guarded or eliminated in accordance with applicable safety provisions.

## 5. SITE INSPECTION

- 5.1 The Department official will, at their discretion, conduct site inspections before,



during, and after each service to evaluate the quality, and completion of the work performed.

## 6 BASIS OF CONTRACT

- 6.1 The general condition of contract of contract (2010 version, issued by National Treasury) as supplemented by terms and condition set out in the terms of reference, shall constitute the basis of the contract between the parties.

## 7 BILLING AND PAYMENT TERMS

- 7.1 Billing will be processed per individual site as provided by NDPWI per the pricing schedule.
