- Conduct regular inspections and maintenance of fire protection systems and equipment to ensure proper functionality and compliance with safety standards.
- Test fire alarms and suppression systems to identify and address any issues that arise.
- Repair and replace faulty components or systems to restore optimal operation.
- Perform site assessments and surveys to determine the specific fire protection system requirements for different locations.
- Identify and report on fire and safety hazards in the base, recommending corrective actions.
- Maintain accurate records of all inspections, maintenance activities, and repairs performed on fire safety systems.
- Assists in fire safety inspection.
- Provide adequate training to the client.
- Follow safety protocols and ensure compliance with industry standards
- Document and report system performance and issues.

Required Skills and Knowledge
