Roles and responsibilities of the Crane Technician (Not limited to):

- Primarily responsible for the assembly, rigging, and maintenance of crane on site by diagnosing and repairing electrical and mechanical faults (including hoisting equipment).
- Inspect, maintain, and repair electrical and mechanical problems on cranes and hoisting equipment.
- Perform mechanical and electrical troubleshooting on various machinery and install and commission new lifting equipment where required.
- Follow safety protocols and ensure compliance with industry standards
- Maintain accurate service records and reports.
- Inspect and certify cranes per statutory and industry requirements.
- Comply with health and safety regulations and ensure all equipment is safe to operate
- Test and certify crane and lifting equipment at Gough Island and provide the required regulatory certificate.
- Maintain job card for work done.
- Conduct preventative maintenance - This proactive approach helps identify potential issues before they escalate, ensuring optimal system performance and longevity.
