## Scope of work for the two mobile Crawler Cranes (Not limited to):

- Servicing, repairs, inspections, load testing and certification of two (2) Mobile Crawler Cranes,
- Ensure optimal performance and extend the lifespan of the cranes.
- · Load testing and certification to comply with safety standards,
- Inspect the boom, jib, and counterweight for damage, cracks, deformation, or corrosion.
- Undercarriage: Check tracks, pads, and track rollers for wear and tear and proper tension.
- Structural integrity: Ensure the crane body is physically sound and free from damage.
- Verify safe and proper access and egress for the operator.
- Fluid levels: Check engine oil, coolant, and hydraulic fluid levels.
- Leaks: Visually inspect the engine and hydraulic hoses and fittings for any signs of leaks.
- Operation: Test hydraulic cylinders for proper operation and monitor the engine for unusual noises or exhaust smoke.
- Lights and indicators: Test head, tail, and indicator lights, as well as alarms.
- Wiring: Inspect wiring harnesses for damage.
- Batteries: Check batteries for proper function.
- Safety devices: Verify that the load moment indicator (LMI), anti-two-block stops, and other limit switches are working correctly if applicable.
- Emergency Stop: Confirm emergency stop buttons are easily accessible and functional.
- Fire Extinguisher: Ensure a properly tagged and tested fire extinguisher is in the cabin.
- Visually inspect main and auxiliary wire ropes for damage, kinks, or excessive wear.
