Tender offers are judged by an evaluation panel in terms of risk to the Employer. Such risk will be evaluated against technical and commercial risk or any other objective criteria listed below. Each criterion carries the same weight / importance and will be evaluated individually by the Bid Evaluation Committee appointed on the project. An assessment of unacceptable risk on any single criterion will constitute unacceptable risk for the award as a whole, resulting in the tender to be disqualified and removed from further consideration.

In order for the evaluation reports to be prepared by the Bid Evaluation Committee, the Tenderer is obliged to provide comprehensive information on form DPW-09 (EC). Failure to complete the said form will cause the tender to be declared non-responsive and removed from any further consideration. Information provided in the returnable documentation must be provided in sufficient detail to enable the evaluation panel to evaluate the risk criteria set out below.

The Employer reserves the right to request further clarification, elucidation, additional documentation / information, etc. as may be required to evaluate the tender. ## C2: PRICING DATA

### C2.1 PRICING ASSUMPTIONS

C2.1.1 Basis of remuneration, method of tendering and estimated fees

C2.1.1.1 Professional fees for provision of **Professional Civil Engineering Services** will be paid on a **value basis as specified in clause C2.1.3**.

The words “value-based” and “percentage based” used in connection with fee types in this document or any documents referred to in this document are interchangeable and are deemed to have the same meaning.

C2.1.1.2 **A percentage of the estimated fees** (in the event of the basis for remuneration being indicated above as a “value-based” fee)

C2.1.2 Remuneration for **Professional Civil Engineering Services**

C2.1.2.1 **Professional fees shall be calculated as follows for the Services rendered by the Service Provider:**

**In the event of the basis for remuneration being a “value-based” fee, the percentage of the normal fees tendered in the “C1.1 Form of Offer and Acceptance”, based on the Cost of the Works, including rates tendered for additional and/or supplementary services and disbursements (C2.2.2.4), all in accordance with the provisions under C2.1.3.**

C2.1.2.2 The amount tendered herein (C1.1) is for tender purposes only and will be amended according to the application of the value fee scale *vis-à-vis* the actual cost of construction (if basis of remuneration has been set at “value-based” according to C2.1.1.1) or the actual number of hours for each level (if basis of remuneration has been set at “time-based” according to C2.1.1.1).

Hourly rates tendered shall be deemed to include overheads and charges in respect of time expended by clerical Personnel which shall, therefore, not be chargeable separately.

C2.1.2.3 The site must be visited as often as the works require for the execution of all duties on the Project. The Service Provider must be available at 24-hour notice to visit the site if so required in case of an emergency other than the prescribed notification period stipulated in the Form of Contract applicable to the Contractor.

C2.1.2.4 Payments to Service Provider

C2.1.2.4.1 Payments to the Service Provider will be made electronically according to the banking details furnished by the Service Provider. Any change in such banking details must be communicated to the Departmental Project Manager (T1.1.4) timeously. Fee accounts, correct in all respects, will be deemed submitted when received by the Employer and settled when electronically processed by the Employer. The Employer reserves the right to dispute the whole account, any item or part of an item at any time and will deal with such case in terms of Clause 14.3 of the General Conditions of Contract.

C2.1.2.4.2 Accounts for Services rendered may be submitted on the successful completion of each stage of work. Interim accounts will only be considered during the construction stage of the works and then not more frequently than quarterly except if otherwise agreed between the authorised and designated representative of the Service Provider and the Departmental Project Manager (T1.1.4). Payment of accounts rendered will be subject to the checking thereof by the Departmental Project



Manager (T1.1.4). The Employer reserves the right to amend the amounts claimed in order to conform to the rates stipulated in this Contract and make payment on the basis of the balance of the account in accordance with Clause 14.3 of the General Conditions of Contract.

C2.1.2.4.3 All fee accounts must be accompanied by an updated original written certification by the quantity surveyor, if appointed, of the amount(s) on which fees are based. The onus, however, rests on the Service Provider to calculate fees on the appropriate value and according to the correct fee scale, read in conjunction with this Contract.

C2.1.2.4.4 Services claimable on time bases (time sheets)

All fees claimable on a time bases (C2.1.3.5) for value-based appointments and for time-based appointments (C2.1.4) must be substantiated by way of submitting a comprehensive time sheet indicating the date, name of person whom rendered the service, description of the service rendered, the number of hours spent in rendering the service, the applicable rate per hour in terms of this agreement and the total amount claimed per incident. The Employer reserves the right to validate the information provided by the Service Provider and will remunerate the Service Provider on what is deemed to be fair and reasonable.

C2.1.2.4.5 Reimbursable rates for typing, printing and duplicating work and forwarding charges as set out under C2.1.6 herein will be paid in full, irrespective of the percentage or rates tendered as referred to in C2.1.1.2 and C2.1.2.1 above.

C2.1.2.4.6 Fee accounts shall be submitted on the Employer's prescribed format, if available. Fee account formats are obtainable on the Employer's Website: <http://www.publicworks.gov.za/> under "Documents"; "Consultants Guidelines"; item 9.3.

C2.1.2.4.7 All fee accounts need to be signed by a principal of the Service Provider and submitted in original format or in electronic format (E-mailed). The "Subject" in E-mail must clearly indicate the fee / invoice claim number. No other versions of fee accounts will be considered for payment.

All fee invoices to be on an official letterhead, indicating the following:

Project Description - WCS number - Date of Invoice - Invoice number - Start and End Dates of time period the fees are claimed and Banking details, failing which the accounts will be returned.

The Departmental Project Manager (T1.1.4) to attach the email to the fee account for auditing purposes.

### **C2.1.3 Value-based fees**

C2.1.3.1 Tariff of Fees applicable

Where value-based fees are payable (if basis of remuneration has been set at "value basis" according to C2.1.1.1), the Service Provider will be remunerated for Services rendered, subject to the provisions in C2.1.2 above and subject to the specific terms and conditions stated below and elsewhere in this document, in accordance with the **2023 National Department of Public Works & Infrastructure Scope of Engineering Services and Tariff of Fees for Persons Registered in terms of the Engineering Profession Act, 2000 (Act No. 46 of 2000) dated 1 April 2023**. This document is referred to as the "2023 NDPWI - Scope of Engineering Services and Tariff of Fees" hereinafter and is appended as Annexure B, or as per the amended and approved applicable Tariff of Fees in terms of Clause C2.1.3.2, and shall be subject to the specific terms and conditions of Clause C2.1.3.

Where there is a discrepancy between the C - clauses within this document and the related Tariff of Fees clauses, the terms and conditions stipulated in the C – clauses shall apply.

C2.1.3.2 Amendment of applicable Tariff of Fees and rates tendered

The applicable Tariff of Fees will only be amended to the latest Tariff of Fees as published by the NDPWI when:

- a) a new version of the Tariff of Fees was published by NDPWI between the date of advertising this Bid and prior to the date of awarding this Bid, or
- b) in terms of Clause 1.2.2 - 3.9.1 (e) [CD], should the project be suspended or where there is no activity for more than two (2) years. The applicable Tariff of Fees as published and in use at the time of uplifting the suspension or resuscitating the project will only be applied to the remaining work stages following the suspension if unchanged, otherwise stages.

The amendment of the applicable Tariff of Fees at the time of award or amendment of the applicable Tariff of Fees and rates tendered after upliftment of suspension or resuscitation of the project are subject to:

- c) the Service Provider submits an application to amend the applicable Tariff of Fees to the Departmental Project Manager (T1.1.4) within 6 weeks of publishing of the revised publication of Tariff of Fees in terms of Clause 3.9.2 of the Contract, failing which, the Service Provider shall not be entitled to amend the applicable fee scale for remuneration,
- d) the Employer elects to retain the services of the Service Provider upon uplifting the Suspension in terms of Clause 8.5.1 of the Contract,
- e) the Departmental Project Manager (T1.1.4) obtains approval, and approval of additional funds required as a contractual obligation in terms of the NDPWI Project Management Delegations, and
- f) the Departmental Project Manager (T1.1.4) confirms the use of the amendment of the latest Tariff of Fees and / or rates in writing.

#### C2.1.3.3 Fees payable for normal services

Remuneration for value-based appointments is based on the percentage of normal fees tendered in the Form of Offer (C1.1) as derived from the Activity Schedule (C2.2.2.4, column (c)), shall be based on the cost of the works and in terms of the 2023 NDPWI - Scope of Engineering Services and Tariff of Fees, or the amended and approved applicable Tariff of Fees (C2.1.3.1).

Normal fees for value-based appointments will be based on the cost of the works and calculated as described in the 2023 NDPWI - Scope of Engineering Services and Tariff of Fees, or the amended and approved Tariff of Fees (C2.1.3.2) i.e. the normal fee multiplied by the value fee scale vis-à-vis the actual cost of construction.

The total fees payable is the cost of the works (Value on which fees can be claimed), which is used to determine the basic fees (Primary fee + secondary fee) to which the applicable increase/ decrease factors are applied, equals normal fees, multiplied by the percentage of normal fees tendered.

The fees payable shall be calculated as follows:

- a) The cost of the works shall be all inclusive of costs associated with:
  - i. The cost of the works emanating from the normal services specified under C3.3.1,
  - ii. Any specific exclusions specified under C3.3.1, and
  - iii. Additional services which increases the cost of the works as specified under C3.3.2.1.
- b) Additional services indicated as “applicable” under C3.3.2 and C3.3.3 which does not increase the cost of the works are deemed to be included in the normal fees unless separately specified in the activity schedule (C2.2.2.4).

- c) The value of the cost of the works to be confirmed by the appointed Quantity Surveyor for Multi-disciplinary Projects (C2.1.2.5) derived from C2.1.3.3 (a) [Sub-total 1 – Cost of the works on which normal fees are to be based].
- d) The basic fees (primary and secondary fees) are based on the cost of the works C2.1.3.3 (c) [Sub-total 1], derived from Clause 4.2.2 (1) for Multi-disciplinary Projects, as described in the applicable Tariff of Fees (C2.1.3.1) [Sub-total 2].
- e) Apply increase/decrease factors to the applicable portions of the work in terms of Clause 4.2.2 (2) for Multi-disciplinary Projects, as described in the applicable Tariff of Fees (C2.1.3.1) [Sub-total 3].
- f) The total normal fees payable is the sum total of C2.1.3.3 (e) [Sub-total 3] multiplied by the percentage of normal fees tendered in the Form of Offer (C1.1) as derived from the Activity Schedule (C2.2.2.4, column (c)).
- g) The percentage of normal fees tendered (C2.2.2.4, column (c)) shall apply to each stage for services provided in stages.
- h) Where the services are to be provided in stages and the proportioning of the fee for normal services over the various stages shall be as set out in the applicable Tariff of Fees (C2.1.3.1), Clause 4.2.8.
- i) Where the Service Provider is required to perform only a portion of the full services, only the relevant portion of the fee shall be paid for services rendered.

#### C2.1.3.4 Fees for documentation for work covered by a provisional sum

Where a provisional sum is included in the bills of quantities for work to be documented at a later stage, the documentation fee in respect of such work shall be remunerated at the time when the documentation has been completed. The fee shall relate to the type of documentation drawn up by the Civil Engineer in respect of each section of such work. Where no documentation has been completed, fees are only payable once the work done by way of a provisional amount allowed in the Bill of Quantities has been completed and certified for payment to the Contractor.

#### C2.1.3.5 Time charges for work done under a value-based fee

Where time charges are payable according to Clause 3.2 and 3.3 of the 2023 NDPWI - Scope of Engineering Services and Tariff of Fees, or as per the amended and approved applicable Tariff of Fees (C2.1.3.1) (if basis of remuneration has been set at “value-based” according to C2.1.1.1), the principles as described in the 2023 NDPWI - Scope of Engineering Services and Tariff of Fees, Clause 4.4, or as per the amended and approved applicable Tariff of Fees (C2.1.3.1) and the rates set out below, will be applicable:

- a) Time charges for this service as tendered under C2.2.2.4 Activity Schedule, will annually be adjusted for inflation for the full duration of the Service Contract Period 3.15.1 [CD] and 3.16.2 [CD], of the of the cidb Standard Professional Service Contract, as amended in C1.2.2 [CD]. The rates claimable are the rates applicable at the time of the execution of the work.
- b) Where the number of hours allowed for in the activity schedule is exceeded whilst within the original Service Contract Period as determined by Clause 3.16.2, of the Contract, as amended in C1.2.2 [CD], the Service Provider is remunerated in terms of C2.1.3.5 (a).
- c) Time charges for work done in excess of the original Service Contract Period (C1.2.2 - 3.15.1 [CD]), will be payable in terms of Clause C2.1.3.5.1.
- d) Where the Activity Schedule did not make provision for rendering services at an hourly rate the hourly rate payable will be in terms of Clause C2.1.3.5.1 upon agreement of the number of hours required and approval issued in writing by the Departmental Project Manager (T1.1.4) in line with the NDPWI Project Management Delegations.

- e) Fees claimable on a time basis shall be claimed by submitting time sheets as described in Clause C2.1.2.4.4

C2.1.3.5.1 Time charges are reimbursable at rates applicable at the time of the actual execution of the specific service. The "Rates for Reimbursable Expenses" as amended from time to time and referred to below, is obtainable on the Employer's Website: <http://www.publicworks.gov.za/> under "Documents"; "Consultants Guidelines"; item 1.

C2.1.3.5.2 The scale of fees on time charges, on which Value Added Tax is excluded, shall be at the following rates per hour, rounded off to the nearest rand: (see Table 8 of "Rates for Reimbursable Expenses" for the actual amounts calculated in accordance with to the principles laid down below):

- (i) for a person in category A and B: 18,75 cents for each R100,00 of the total annual remuneration package attached to the lowest notch of a level 13 salary range (Director) in the Public Service;
- (ii) for a person in category C: 17,5 cents for each R100,00 of the total annual remuneration package attached to the lowest notch of a level 12 salary range (Deputy Director second leg.) in the Public Service;
- (iii) for a person in category D: 16,5 cents for each R100,00 of his/her gross annual remuneration; provided that this hourly rate shall not exceed 16,5 cents for each R100,00 of the total annual remuneration package attached to the lowest notch of a level 11 salary range (Deputy Director first leg.) in the Public Service.

Hourly rates calculated in terms of (i), (ii) and (iii) above shall be deemed to include overheads and charges in respect of time expended by clerical Personnel which shall, therefore, not be chargeable separately.

C2.1.3.5.3 Unless otherwise specifically agreed in writing, remuneration for the time expended by principals in terms of C2.1.3.5.2(i) above on a project shall be limited to 5 per cent of the total time expended for time charges in respect of the Project. Any time expended by principals in excess of the 5 per cent limit shall be remunerated at the rates determined in (ii) or (iii) above.

C2.1.3.5.4 Notwithstanding the above, where work is of such a nature that Personnel as described in C2.1.3.5.2 (iii) above are capable of performing such work, it shall be remunerated at that level and not at the rates described in (i) and (ii) above, irrespective of who in fact executed the work.

C2.1.3.5.5 Gross annual remuneration in C2.1.3.5.2(iii) above shall mean basic salary and guaranteed annual bonus; fringe benefits not included in basic salary; income benefit, as determined from time to time by the South African Revenue Services for income tax purposes, for the private use of a motor vehicle by the Employer; Employer's contribution to pension/provident fund, medical aid and group life assurance premiums; Compensation Fund and Unemployment Fund contributions, Metropolitan Council levies and any other statutory contributions or levies; all other costs and benefits as per conditions of appointment but excluding any share of profit and payment for overtime.

C2.1.3.5.6 The salaries referred to in C2.1.3.5.2(i) to (iii) above can change from time to time, which will, therefore, change the rates applicable. These rates will, however, only be adjusted on the first day of each calendar year irrespective of any changes in salary ranges during the relevant year. The rates applicable at the time of the execution of the work as set out in Table 8 of the "Rates for Reimbursable Expenses", as adjusted from time to time, may be claimed.

#### C2.1.3.6 Additional Services

C2.1.3.6.1 Additional Services pertaining to all Stages of the Project (Clause 3.3 Tariff of Fees) including: Additional services will be remunerated as described below:

- a) The cost of providing all additional services as specified and/or indicated as being "Applicable" in C3.3.2. or C3.3.3 which does not increase the cost of the works shall be deemed to be included in the percentage of normal fees tendered for normal services, unless specified

separately in the Activity Schedule C2.2.2.4 or C2.2.3.4 No separate payment shall be made for the additional services specified in C3.3.2 and C3.3.3.

- b) Additional services that may be required during any stage of the project, which has not been specified and/or not indicated as being “Applicable” under C3.3.2 or C3.3.3, which increases the cost of the civil works will be remunerated in terms of the percentage of normal fees tendered.
- c) Should the need arise for additional services that does not increase the cost of the civil works, the Service Provider will be remunerated on a time basis:
  - i. Where provision was made for hourly rates for additional services in the pricing activity schedule (C2.2.2.4 or C2.2.3.4) and an hourly rate was tendered, the hourly rate will be payable. Time-charges for this service as tendered under in the activity schedule (C2.2.2.4 or C2.2.3.4), will annually be adjusted for inflation (C2.1.3.5 (a)) for time charges for work done under a value-based fees or in terms of C2.1.4.1 for time-based fees.
  - ii. Where the number of hours allowed for in the activity schedule (C2.2.2.4 or C2.2.3.4) is exceeded whilst within the original Service Contract Period (C1.2.2 - 3.15.1 [CD]) as determined by Clause 3.16.2, of the Contract, as amended in C1.2.2 [CD], the Service Provider shall be remunerated in accordance with C2.1.3.6.1 (c) (i).
  - iii. Where the Activity Schedule (C2.2.2.4 or C2.2.3.4) did not make provision for rendering additional services at an hourly rate the service provider will be remunerated in accordance with Clause 4.3 and 4.4 of the applicable Tariff of Fees (C2.1.3.1). Where the applicable Tariff of Fees do not specify a method of remuneration, the Service Provider will be remunerated in accordance with C2.1.3.5.1.
- d) Other costs associated with the additional services on a time basis will be remunerated as follows:
  - i. Typing and Duplicating (C2.1.6),
  - ii. Travelling and Subsistence (C2.1.7) which are subject to submission of time sheets in accordance with C2.1.2.4.4.
- h) Where provision was made in the Activity Schedule (C2.2.2.4 or C2.2.3.4) for additional services, the Departmental Project Manager (T1.1.4) obtains approval, and approval of additional funds as a contractual obligation in terms of the NDPWI Project Management Delegations, prior to the commencement of the work in accordance with C2.1.3.2 (d) to (f).
- i) Additional services, which has not been specified under C3.3.2 or C3.3.3 nor any provision made in the Activity Schedule, constitutes a variation order. The Departmental Project Manager (T1.1.4) obtains approval and approval of additional funds as a contractual obligation in terms of the NDPWI Project Management Delegations, prior to the commencement of the work, all in accordance with C2.1.3.2.

#### C2.1.3.6.2 Construction monitoring (Clause 3.3.2 Tariff of Fees)

Provision of Site Personnel for **Level 1, part time** construction monitoring is required. The cost of all site Personnel rendering Level 1, part time construction monitoring, will be deemed to be included in the applicable fees as stated in C2.1.1.1 above. Level 2, full time construction monitoring to be specified and priced separately in the Activity Schedule C2.2.2.4 or C2.2.3.4.

The construction monitoring requirements are as specified in C3.3.2.2.

- (a) If Level One, part time, monitoring has been specified then no separate payment shall be made for construction monitoring staff as specified in C3.3.2.2 (i)-(iii) or for the transport of the



monitoring staff as specified in C3.3.2.2 (iv). The cost of providing construction monitoring staff and transport shall be deemed to be included in the value-based fee tendered for normal services.

- (b) If Level Two, full time, monitoring has been specified then provision shall be made in the Activity Schedule for the envisaged site staffing requirements as specified in C3.3.2.2 (i)-(iii). The unit of measure shall be the rate per calendar month (*pro rata* for part of a month). Payment shall only be applicable for the period actually established on site and shall in no instance be prior to the date of official handover of the Works to the Service Provider or after the date of issue of the Certificate of Completion for the Works contract. The rates tendered for the relevant site staff shall include full compensation for all costs including, inter alia, the following:

- Salary
- Additional allowances
- Bonuses
- Leave and sick leave
- All company contributions such as provident fund, group life benefits, medical aid etc.
- Levies
- Office equipment as set out in C3.3.2.2 (iii)
- Relocation cost and accommodation
- Travelling
- Handling cost and profit.

It is the Service Provider's responsibility to ensure that full-time supervision is continued on site when the appointed personnel is either on leave or sick leave. The replacement personnel must be approved at the commencement of the project. The replacement personnel will be provided at no additional cost. Time sheets for staff shall be included in the monthly fee account submitted to the Departmental Project Manager (T1.1.4) for payment. Replacement of staff as a result of any extended period of leave or sick leave outside of the normal Service Provider's year end break shall be to the approval of the Employer.

No separate payment shall be made for the transport of the construction monitoring staff as specified in C3.3.2.2 (iv) and the cost of the transport shall be deemed to be included in the monthly rate tendered for the provision of the staff.

#### C2.1.3.6.3 Occupational Health and Safety Act, 1993 (Act No. 85 of 1993) (Clause 3.3.3 Tariff of Fees).

The Employer shall appoint a Service Provider under a separate contract as its "agent" as contemplated in the Construction Regulations to the Occupational Health and Safety Act, 1993 (Act 85 of 1993).

No separate payment shall be made for the service specified in C3.3.2.3. The cost of providing this service shall be deemed to be included in the value-based fee tendered for normal services.

Where services are required but not specified under C3.3.2.4 and where no allowance was made in the Activity Schedule (C2.2.2.4 or C2.2.3.4), the Service Provider will be remunerated in accordance with C2.1.3.6.1 (c iii).

#### C2.1.3.6.4 Quality Assurance System (Clause 3.3.4 Tariff of Fees)

No separate payment shall be made for the implementation of a quality management system as specified in C3.3.2.4 and indicated as "Applicable". The cost of providing this service shall be deemed to be included in the value-based fee tendered for normal services.

Where services are required but not indicated as "Applicable" under C3.3.2.4 and where no allowance was made in the Activity Schedule (C2.2.2.4 or C2.2.3.4), the Service Provider will be remunerated in accordance with C2.1.3.6.1 (c iii).

#### C2.1.3.6.5 Lead Consultant / Consulting Engineer (Clause 3.3.5 Tariff of Fees)

No separate payment shall be made for assuming the leadership of an Employer specified joint venture, consortium or team of consulting engineers as specified in C3.3.2.5 and indicated as “Applicable”. The cost of providing this service shall be deemed to be included in the value-based fee tendered for normal services.

Where services are required but not indicated as “Applicable” under C3.3.2.5, Clause 4.3 (6) of the applicable Tariff of Fees (C2.1.3.1) shall be applicable.

#### C2.1.3.6.6 Principal Agent of the Client (Clause 3.3.6 Tariff of Fees)

Services as a Principal Agent is only payable if two (2) or more design consultants have been appointed over and above the Health and Safety Agent and/or Social Facilitator.

No separate payment shall be made for assuming the role of principal agent of the Employer if specified in C3.3.2.6 and indicated as “Applicable”. The cost of providing this service shall be deemed to be included in the value-based fee tendered for normal services.

When “Applicable” under C3.3.2.6 and the Service Provider fails to perform the Principal Agent duties with due diligence, one percent (1%) of the total cost of the works comprising the project (Clause 4.3 (7) of the applicable Tariff of Fees (C2.1.3.1)) will be deducted to determine basic fees for fee calculation after which any inclusions/exclusions and/or increase/decrease factors will be applied of which the sum total will be multiplied by the percentage of normal fees tendered.

Where services are required but not indicated as “Applicable” under C3.3.2.6, additional fees will be paid for acting as principal agent in accordance with 4.3 (7) of the applicable Tariff of Fees (C2.1.3.1).

#### C2.1.3.6.7 Environmental Impact Assessment

No separate payment shall be made for the service specified in C3.3.2.7 and indicated as “Applicable”. The cost of providing this service shall be deemed to be included in the value-based fee tendered for normal services. Provision to be made in the Activity Schedule (C2.2.2.4 or C2.2.3.4) for the appointment of an EIA specialist.

Where services are required but not indicated as “Applicable” under C3.3.2.7, additional time-based fees will be remunerated in accordance with C2.1.3.6.1(c iii).

#### C2.1.3.6.8 Other unspecified services

The Employer may order duties that fall outside the scope of the project as tendered. Any such additional services that may be required as set out under C3.3.3.

Any such additional services that may be required will be remunerated on a Time Basis in accordance with C2.1.3.6.1(c iii), subject to submission of time sheets in accordance with C2.1.2.4.4. The level of expertise necessary for any such additional work shall be concomitant with the issues to be addressed. The category of personnel necessary to undertake the work shall be approved by the Departmental Project Manager (T1.1.4). Any additional identified service shall be fully scheduled and submitted to the Departmental Project Manager (T1.1.4) for approval prior to the commencement thereof.

#### C2.1.3.6.9 Alternative tenders

No fee shall be payable for documentation prepared for alternative tenders involving the mere substitution of material not requiring any design, measurements or calculation.

#### C2.1.3.7 Excessive Variation in Time (Construction Period)

In the event of the initial contract period being exceeded by more than 10 per cent, through no fault of the engineering professional, the engineer is to be remunerated for all additional work over and above the period exceeding the additional 10%, resulting from the extension of time. The hourly rates according to the then current departmental hourly rate together with related reimbursables shall apply.

#### C2.1.3.8 Determining interim payments due to the Service Provider

Interim payments to be made as defined in C2.1.2.4 above. For the purposes of ascertaining the interim payments due, the cost of the works, which shall exclude any provisional allowances made to cover contingencies and escalation shall be:

- a) the net amount of the accepted tender, or
- b) if no tender is accepted, the net amount of the lowest acceptable tender in terms of C2.1.3.8.2.1 (b), unless acceptable motivation can be provided to prove that such amount is unreasonable, or
- c) if the contract is awarded by negotiation the negotiated price.
- d) if no tenders are invited or if no acceptable tenders are received or if no negotiation is concluded, the estimate. The estimate shall be the one accepted by the Departmental Project Manager (T1.1.4) as representing the value of the works, which for purposes of interim payments will be deemed to be 80% of the engineer's / quantity surveyor's estimate, if appointed.

**C2.1.3.8.1 Abortive work (after concept design and sketch plan design was approved) (Abortive design)**

In the event of the design being changed after concept or sketch plan approval (on which the elemental estimate and bills of quantities was completed) to such an extent that it requires a new design, elemental estimate and bills of quantities, the abortive fees payable will be determined by applying the percentage of normal fees tendered claimable fee of the work stages completed or partially completed, based on the percentage of the estimate as indicated below:

- a) at time of suspension or cancellation during the planning stage - 80% of the PQS / Engineer's estimate, excluding provisional sums, or
- b) just prior to inviting tenders or during tender stage but before the closing of tenders - 80% of the PQS / Engineer's pre-tender estimate, excluding provisional sums.
- c) after closing of tenders but prior to recommendation of a tender - 100% of the responsive tender with the lowest price where there is an acceptable tender, excluding provisional sums. Where there are no responsive tenders then C2.1.3.8.2.1 (b) will apply, or
- d) a tender has been recommended for award - 100% of the recommended bidder's tender price, excluding provisional sums,

For the new design:

The fees payable will be for Stages 1 to 6 (dependant on Departments determination) on value basis (percentage of normal fees tendered) calculated on the new project value subject to the criteria a) to b) set above: (Note: if project moves to a new location then Stages 1-6 can be considered). Fees will be remunerated based on the applicable Tariff of Fees (C2.1.3.1).

Or

If the changes do not require a full design change, elemental estimates and bills of quantities, then stages 1 to 4 (dependant on the Departments determination) will be remunerated on time basis. Fees will be remunerated based on the applicable Tariff of Fees (C2.1.3.2) for stages 5 and 6 at tendered fees calculated on final account of the new design.

**C2.1.3.8.2 Remuneration upon Suspension or Cancellation of the Project before commencement of Construction**

**C2.1.3.8.2.1** In the event of the project being suspended or cancelled prior to the commencement of the construction works, the fees payable (Stages 1 to 4) will be in terms of the percentage of normal fees tendered and applying the applicable Tariff of Fees (C2.1.3.1), determined by applying the percentage claimable fee of the work stage completed or partially completed, based on the percentage of the estimate as indicated below:

- a) at time of suspension or cancellation during the planning stage (Stages 1 to 3) - 80% of the PQS / Engineer's estimate, excluding provisional sums., or
- b) just prior to inviting tenders or during tender stage (Stage 4) but before the closing of tenders (Stage 4) - 80% of the PQS / Engineer's pre-tender estimate, excluding provisional sums.



- c) after closing of tenders but prior to recommendation of a tender - 100% of the responsive tender with the lowest price where there is an acceptable tender, excluding provisional sums. Where there are no responsive tenders then C2.1.3.8.2.1 (b) will apply, or
- d) a tender has been recommended for award (Stage 4) - 100% of the recommended bidder's tender price, excluding provisional sums.
- e) a tender has been awarded but no work has commenced (Stage 4) - 100% of the recommended bidder's tender price excluding provisional sums.
- f) In the event of the project being suspended or cancelled after the commencement of the works, fees will be remunerated in terms of the percentage of normal fees tendered and applying the applicable Tariff of Fees (C2.1.3.1), based on 100% of the net amount of the accepted tender, excluding provisional sums, for Stages 1 to 4 and 100% of the final account value of the work done and certified when the contract is terminated during Stages 5 or 6.

C2.1.3.8.2.2 In the event of the upliftment of suspension (and where the original scope and value of works has drastically reduced due to revised needs, however same design can be used), fees will be payable as follows:

- g) Fees for Stages 1 to 4 for original scope will be remunerated on the percentage of normal fees tendered for the service rendered on the original scope, as explained above (a-c),
- h) In terms of continuation of project, remuneration for stage 1 to 4 will only be applicable to new scope of work, in which case fees will be based on an hourly basis.
- i) Fees will be remunerated on an hourly basis for the amendments of the Bills of Quantities for the new scope / re-evaluation of tenders, etc.
- j) The hourly rates payable will be in terms of C2.1.3.5, subject to the submission of time sheets in accordance with C2.1.2.4.4.
- k) All consultants must obtain written confirmation, with regards to the scope of services required for stages 1 to 4 work on the new scope, from the Project Manager prior to commencing with the work.
- l) Fees will be remunerated in terms of the percentage of normal fees tendered and applying the applicable Tariff of Fees (C2.1.3.1), for stages 5 and 6 based on the final account value of the new scope.

The Departmental Project Manager (T1.1.4) may elect to terminate the services of the Service Provider in terms of Clause 8.4 of the Service Contract or elect to retain and / or suspend the Services of the Service Provider in terms of Clause 8.5 of the Service Contract.

C2.1.3.8.3 Remuneration when Construction Contracts are Cancelled resulting in Completion Contracts  
When the Construction Contract is cancelled during the construction period by either the Employer or the Contractor, the following will apply:

Original contract

- a) Fees will be remunerated based on the percentage of normal fees tendered and applying the applicable Tariff of Fees (C2.1.3.1), based on 100% of the net amount of the accepted tender, excluding provisional sums, for Stages 1 to 4. Provisional sums will only be considered if the final scope has been established and quotations approved.
- b) Fees for stages 5 and 6 will be based on 100% of the final account value of the cancelled contract.
- c) Fees can only be claimed for stages where services were rendered.

Completion contract

- d) In terms of completion contracts, remuneration for Stages 1 to 4 will only be applicable to new scope of work, in which case fees will be based on an hourly basis.
- e) Fees can only be claimed for stages where services were rendered.
- f) Fees will be remunerated on an hourly basis for the compilation of the Bills of Quantities and Tender Documentation for the Completion Contract.
- g) The hourly rates payable will be in terms of C2.1.3.5 subject to submission of time sheets in accordance with C2.1.2.4.4.

- h) All consultants must obtain written confirmation, with regards to the scope of services required for Stages 1 to 4 work on the Completion Contract, from the Project Manager prior to commencing with the work.
- i) Fees will be remunerated based on the percentage of normal fees tendered and applying the applicable Tariff of Fees (C2.1.3.1), based on 100% of the final account value of the when the contract is terminated during Stages 5 or 6.

The employer may elect not to retain the services of the Service Provider in terms of Clause 8.4 of the Contract upon which Clause C1.2.2 - 5.8 [CD] shall apply or elect to retain and /or suspend the services of the Service Provider in terms of Clause 8.5 of the Service Contract,

#### C2.1.3.8.4 Interim payments for Stage 5

Interim payments for Stage 5 will be allowed as defined in C2.1.3.8 above. One third of the fees for Stage 5 on engineering projects however, will be apportioned to the draft final account which must be a complete draft final account for the Project, or any separate identifiable phase of the Project, complete in all respects for the Employer to verify for correctness. Interim payments for the draft final account will be allowed only when it has been received by the Employer.

#### C2.1.3.8.5 Interim payments for work stage 6

Interim payments for work stage 6 will be allowed only when an acceptable and complete final account for the Project, or any separate identifiable phase of the Project, has been received by the Departmental Project Manager (T1.1.4) provided that the relevant fee shall be subject to a factor of 80%.

#### C2.1.3.9 Fees claimable on a time basis shall be claimed by submitting time sheets in accordance with Clause C2.1.2.4.4

#### C2.1.3.10 Labour-intensive work

In terms of C3.3.2.8, all Services relating to the implementation of the works which are to be provided in terms of the Guidelines for the Implementation of Labour-Intensive Infrastructure Projects under the Expanded Public Works & Infrastructure Programme (EPWP) are normal services in terms of the 2023 NDPWI - Scope of Engineering Services and Tariff of Fees or as per the amended and approved applicable Tariff of Fees (C2.1.3.1).

Any changes in the design of the works to incorporate labour-intensive works specified in C3.3.2.8 should not constitute a change in scope or an additional service where the scope of work is framed around such publications.

Any changes in the design of the works to incorporate labour-intensive works when not specified under C3.3.2.8 may constitute a change in scope or an additional service, subject to approval by the Departmental Project Manager (T1.1.4) in accordance with C2.1.3.5.

### C2.1.4 Time-based fees

#### C2.1.4.1 Fees for work done under a time-based fee

Where time-based fees are payable (if basis of remuneration has been set at "time basis" according to C2.1.1.1), the principles as described in Clauses 4.4 (1), (2) and (3) of the 2023 NDPWI - Scope of Engineering Services and Tariff of Fees, or the amended and approved Tariff of Fees (C2.1.3.10), excepting that the rates referred to in Clause 4.4 (3) shall be replaced by the various rates per hour tendered for the various categories in C2.2.3.4 Activity Schedule for Time-based Fees, column (e). The rates claimable are the rates applicable at the time of the execution of the work. The rates payable will be as follows:

- a) Time charges for this service as tendered under C2.2.3.4 Activity Schedule, will annually be adjusted for inflation (C1.2.2 - 3.16.2 [CD]) for the full duration of the Service Contract Period (C1.2.2- 3.15.1 [CD]).
- b) Where the number of hours allowed for in the activity schedule is exceeded whilst within the original Service Contract Period (C1.2.2 - 3.15.1 [CD]) as determined by Clause 3.16.2, of the Contract, as amended in C1.2.2 [CD], the Service Provider is remunerated in terms of C2.1.4.1 (a).
- c) Time charges for work done in excess of the original Service Contract Period (C1.2.2- 3.15.1 [CD]), will be calculated in terms of Clause C2.1.3.5.1.
- d) Where the Activity Schedule did not make provision for rendering services at an hourly rate, the hourly rate payable will be calculated in terms of C2.1.3.5.1.
- e) Fees claimable on a time basis shall be claimed by submitting time sheets in accordance with Clause C2.1.2.4.4

Where there is a discrepancy between the C - clauses within this document and the related Tariff of Fees clauses, the terms and conditions stipulated in the C – clauses shall apply.

C2.1.4.2 The various categories referred to in C2.2.3.4 Activity Schedule for Time-based Fees, are the categories described in Clauses 4.4 (2) of the 2023 NDPWI - Scope of Engineering Services and Tariff of Fees.

C2.1.4.3 Work will be remunerated for at the category level in which it falls as defined in C2.1.4.2 above, irrespective of whether the person who in fact had executed the work functions at a higher category of responsibility and competence.

C2.1.4.4 Remuneration upon Suspension or Cancellation of the Project prior to commencement of the Construction Project.

In the event of the project being suspended or cancelled prior to the commencement of the construction, the fees claimable on a time basis by the Service Provider will be determined as follows:

The hourly rate for proven time spent (time sheets) on providing professional services on the project, plus cost of all re-imbursements till date of suspension or cancelation of the Project, irrespective during which phase of the project life cycle prior to commencement of construction, the project is suspended or cancelled.

C2.1.4.5 Fees claimable on an hourly basis is subject to submitting time sheets in accordance with C2.1.2.4.4.

#### **C2.1.5 Set off**

The Employer reserves the right to set off against any amount payable to the Service Provider, any sum which is owing by the Service Provider to the Employer in respect of this or any other departmental project.

#### **C2.1.6 Typing, printing and duplicating work and forwarding charges**

The Provisional amount allowed for in the activity schedule is the total sum of Typing and Duplicating, Drawing Duplication and Forwarding Charges (C2.1.6.1 to C2.1.6.4), which is adjustable (Remeasurable). Reimbursable rates for typing, printing and duplicating work and forwarding charges will be paid in full.

Where an allowance was made in the Activity Schedule by way of inserting a provisional amount and any increases are required, the adjustment will constitute a contractual obligation in terms of the NDPWI Project Management Delegations to be reimbursed in accordance C2.1.6.1 to C2.1.6.4. Where no allowance was made in the Activity Schedule for reimbursing travelling time charges will constitute a variation order in terms of the NDPWI Project Management Delegations. Both instances are subject to C2.1.3.2 (d) to (f).

#### C2.1.6.1 Reimbursable rates

The costs of typing, printing and duplicating work in connection with the documentation which must of necessity be done, except those which must in terms of the relevant Manual or other instructions be provided free of charge, shall be reimbursable at rates applicable at the time of the execution of such work. The document "Rates for Reimbursable Expenses" as amended from time to time and referred to below, is obtainable on the Employer's Website: <http://www.publicworks.gov.za/under> "Documents"; "Consultants Guidelines"; item 1.

#### C2.1.6.2 Typing and duplicating

If the Service Provider cannot undertake the work himself, he may have it done by another Service Provider which specialises in this type of work and he shall be paid the actual costs incurred upon submission of statements and receipts which have been endorsed by him confirming that the tariff is the most economical for the locality concerned.

If the Service Provider undertakes the work himself, he shall be paid in respect of actual expenses incurred subject to the maximum tariffs per A4 sheet as set out in Table 1 in the "Rates for Reimbursable Expenses".

Typing and duplicating expenses shall only be refunded in respect of the final copies of the following documents namely formal reports, formal soil investigation reports, specifications, feasibility reports, bills of quantities, material lists, minutes of site meetings and final accounts. The cost of printed hard covers shall only be paid in respect of documents which will be made available to the public such as bills of quantities and specifications or where provision of hard covers is specifically approved.

The typing of correspondence, appendices and covering letters are deemed to be included in the value-based fees and time-based fees paid.

#### C2.1.6.3 Drawing duplication

- (a) For drawing duplication, the standard rate as set out in Table 2 in the "Rates for Reimbursable Expenses" may be claimed or may be claimed according to the provisions as in (b) or (c) below.
- (b) If the Service Provider undertakes the duplication of drawings, using his own duplication equipment, he shall be paid the actual cost incurred on condition that it is not higher than the lowest of three quotations of local firms doing drawing duplication in his locality. Such quotations must accompany his account.
- (c) If the Service Provider does not undertake his own drawing duplication, he shall be paid the lowest of three quotations of local firms doing plan printing in his locality. Such quotations must accompany his account.
- (d) Should there not be three firms doing drawing duplication in his locality, it must be mentioned on his account and the available quotation(s) must then accompany the account.

(The cost of providing all polyester negative prints required to form part of the original set of drawings, as-built drawings including computer assisted drawing records for all facets/disciplines involved in the project are included in the tendered fees and will not be reimbursed separately.)

#### C2.1.6.4 Forwarding charges

- (a) Only the charges in respect of the forwarding of parcels by courier or air freight on special request by the Departmental Project Manager (T1.1.4) will be refunded, provided that such charges will not be refunded if the request had been made as a result of a delay caused by the Service Provider.
- (b) The cost of postage, facsimile transmissions, telephone calls, e-mails, etc, is deemed to be included in the value-based fees and time-based fees paid.

#### C2.1.7 Travelling and subsistence arrangements and tariffs of charges

Traveling and substance quantities in terms of number of trips are adjustable and is a contractual obligation in terms of the NDPWI Project Management Delegations where allowed for in the Activity Schedule whereby the Departmental Project Manager (T1.1.4) must obtain approval, approval of the additional funds and confirm in writing to the Service Provider prior to undertaking the additional trips and / or applying the adjusted rates (C2.1.3.2 (d) to (f)).

When the Service Provider is requested in writing by or obtained prior approval in writing from the Employer to attend specific meetings at any of the Employer's offices or any extraordinary meetings on site or elsewhere, he will be remunerated according to the provisions under C2.1.7.1 to C2.1.7.6 herein.

##### C2.1.7.1 General

As the tariffs referred to hereunder are adjusted from time to time, accounts must be calculated at the tariff applicable at the time of the expenditure.

Where journeys and resultant costs are in the Employer's opinion related to a Service Provider's malperformance or failure, in terms of this Contract, to properly document or co-ordinate the work or to manage the Contract, no claims for such costs will be considered.

Reimbursement of traveling expense charges in terms of Traveling Time (C2.1.7.2) Traveling Costs (C2.1.7.3), Subsistence Allowance (C2.1.7.5) and Toll Road fees (C2.1.7.6) will be as described below:

- a) Traveling expense charges for this service as tendered under C2.2.2.4 or C2.2.3.4 in the Activity Schedule, will annually be adjusted for inflation (C1.2.2 - 3.16.2 [CD]) for the full duration of the Service Contract Period (C1.2.2 - 3.15.1 [CD]).
- b) In the event of the number of trips allowed for in Table A under C2.2.2.4 or C2.2.3.4 in the Activity Schedule be exceeded whilst within the Service Contract Period (C1.2.2 - 3.15.1 [CD]), the Service Provider will be reimbursed in terms of C2.1.7.1 (a).
- c) In the event of a variation in the Service Contract Period (C1.2.2 - 3.15.1 [CD]) irrespective whether allowance was made in the Activity Schedule or if no allowance was made in the activity schedule for reimbursing traveling expense charges, the Service Provider will be reimbursed in accordance with the "Rates for Reimbursable Expenses" as amended from time to time and referred to below, is obtainable from the Departmental Project Manager (T1.1.4) or on the Department's Website: <http://www.publicworks.gov.za/consultantsdocs.html>, subject to C2.1.3.2 (d) to (f).
- d) Where allowance was made in the Activity Schedule to price travelling expense charges will constitute a contractual obligation in terms of the NDPWI Project Management Delegations to be reimbursed. Where no allowance was made in the Activity Schedule for reimbursing travelling expense charges will constitute variation order in terms of the NDPWI Project Management Delegations. Any increase in the required cost in both instances is subject to C2.1.3.2 (d) to (f).

##### C2.1.7.2 Travelling time



Travelling time will be fully reimbursed. No travelling time will be paid in respect of journeys to DPWI Head Office or the office of the Departmental Project Manager (T1.1.4) without prior approval in writing.

**C2.1.7.3 Travelling costs**

The most economical mode of transport is to be used taking into account the cost of transport, subsistence and time. Accounts not rendered in accordance herewith may be reduced to an amount determined by the Employer.

Travelling costs will be refunded for the full distance covered per return trip measured from the office of the Service Provider appointed. Travelling expenses are reimbursable at rates applicable at the time of the actual execution of the specific service and incurring the cost in terms of C2.1.7.1 (a) to (d).

Compensation for the use of private motor transport will be in accordance with the Government tariff for the relevant engine swept volume, up to a maximum of 3000 cubic centimetres, prescribed from time to time and as set out in Table 3 in the “Rates for Reimbursable Expenses” when C2.1.7.1 (c) is applicable.

**C2.1.7.4 Hired vehicles**

In cases where use is made of hired vehicles, the most economical sized vehicle available is to be used but compensation shall nevertheless be restricted to the cost of a hired car not exceeding a capacity of 1300 cc. Where use of a special vehicle is essential (e.g. four track or minibus to accommodate more people), prior approval in writing must be obtained from the Departmental Project Manager (T1.1.4).

**C2.1.7.5 Subsistence allowance**

Subsistence expenses are reimbursable at rates applicable at the time of the actual date of execution of the specific service and incurring the cost in terms of C2.1.7.1 (a) to (d).

Should the daily tariff as set out in Table 4 be inadequate, substantiated actual costs plus a special daily allowance as shown in Table 5 for incidental expenses, may be claimed. It must be noted that claims may only be according to Table 4 or Table 5 in the “Rates for Reimbursable Expenses”. Accommodation should be limited to the equivalent of a three-star hotel and no alcoholic beverages or entertainment costs may be claimed for.

Only actual costs are payable in respect of absence from office of less than 24 hours.

**C2.1.7.6 Toll road fees**

Toll road fees will be fully reimbursed. No toll road fees will be paid in respect of journeys to DPWI Head Office or the office of the Departmental Project Manager (T1.1.4) without prior approval in writing.

No claims for toll road fees will be entertained where allowance was made to price toll road fees in the activity schedule but was not priced by the Service Provider.

**C2.1.8 Appointment of Specialist Consultants and / or Service Providers (Provisional Amounts)**

Provisional amounts allowed for in the Activity Schedule (C2.2.2.4 or C2.2.3.4) are adjustable as a contractual obligation in terms of the NDPWI Project Management Delegations whereby the Departmental Project Manager (T1.1.4) must obtain approval of the additional funds and confirm in writing to the Service provider prior to exceeding the provisional amount allowed in accordance with C2.1.3.2 (d) to (f).

The provisional amounts allowed for in the Activity Schedule will be reimbursed as follows:

- a) Where provision was made for in the Activity Schedule for the Service Provider to appoint a specialist consultant and / or a service provider to perform the required services, he shall be paid the lowest of three quotations as approved by the Departmental Project Manager (T1.1.4), and be paid the surcharge fee based on the percentage tendered in the Activity

Schedule. Additional funds required will constitute a contractual obligation in terms of the NDPWI Project Management Delegations.

Or

- b) If the Service Provider has the in-house capability to render such service, the Service Provider will be remunerated at the hourly rate tendered in the Activity Schedule for Additional Services in terms of C2.1.3.5, and approved in writing by the Departmental Project Manager (T1.1.4) in accordance with C2.1.3.2 (d) to (f).

#### C2.1.9 Supplementary Services: Administration of Contract Participation Goals

When applicable in terms of C3.3.4. the Service Provider will be remunerated at an hourly rate as tendered for administration in terms of time spent in liaising, coordinating, sourcing and verification of documents submitted, compilation of the feasibility study including related meetings pertaining to and submitting reports as required to the following Targeted Procurement and Contract Participation Goals applicable to the Construction Project which shall include but not be limited to: Local Material Local Material Manufacturers, Local Material suppliers, Skills development, SMME participation, EPWP and NYS labour reporting, labour Intensive Work, the use of and Content, the cidb B.U.I.L.D. Programme and any other Contract Participation Goals applicable to the construction project. The hourly rate will be adjusted in accordance with Clause 3.16.1 of the cidb Standard Professional Service Contract and Clause C1.2.2 - 3.16.2 [CD]. The Service Provider will be reimbursed in terms of C2.1.3.5 subject to submitting time sheets as described in Clause C2.1.2.4.4.

#### C2.1.10 Co-Funded Projects

When applicable as specified under C3.16, the service provider shall make allowance in the percentage of normal fees or hourly rates tendered to render services as described under C3.

When not specified under C3.16 as being applicable and Co-funding becomes applicable the Service Provider will be paid at the hourly rate tendered in accordance with C2.1.3.5 for Value Based appointments or C2.1.4.1 for Time based appointments, whichever applicable for submitting additional invoices for the associated cost apportioned to the co-funded portion.

##### a) Apportionment of Fees

- i. Determine the total value of the works of the project, including Preliminaries and CPAP (when applicable) for each discipline (Sub-total 1).
- ii. Apply any inclusions / exclusions to determine final value of the work in accordance with the applicable Tariff of Fees and/or C3 Scope of Work (Sub-total 2)
- iii. Calculate normal fees based on the total value of the works in accordance with the applicable Tariff of Fees (Sub-total 3).
- iv. Apply the respective increase/ decrease factors in accordance with the applicable Tariff of Fees (Sub-total 4).
- v. Apply percentage of normal fees tendered (Sub-total 5).
- vi. Apportion Sub-total 5 between the respective values of work for Repairs & Renovations (Sub-total 6) and Capital Works / Co-funded portions of the Works respectively: (Sub-total 7).
- vii. Fees claimable shall be apportioned to the stages in accordance with the Tariff of Fees.

##### b) Apportionment of Time-based fees for additional and supplementary services

The total cost will be apportioned to the respective values of work for Repairs & Renovations and Capital Works/ Co-funded portions of the Works respectively.

##### c) Apportionment of Disbursements

Disbursements include: typing, printing & duplicating and forwarding charges, and all travelling related costs.



The total disbursements will be apportioned to the respective values of work for Repairs & Renovations and Capital Works / Co-funded portions of the Works respectively.

- d) The Service provider shall submit two separate invoices with one supporting document attached to both invoices, illustrating calculations of fees including all other expenses as well as the apportionment of the costs between Repairs & Renovations including Alterations and Capital Works/ Co-funded portions of the Works respectively.



## C2.2 ACTIVITY SCHEDULE

C2.2.1 Civil Engineering Services, as defined in the C3 Scope of Services are required for a multi-disciplinary project (C3.1). The activity schedule below lists the normal services as defined in the 2023 NDPWI - Scope of Engineering Services and Tariff of Fees (Clause 3 (Annexure B)), and as further defined in C3 Scope of Services, including additional services as defined in C3.3.2 and C3.3.3 unless specified separately in the Activity Schedule (C2.2.2.4), of this document.

Adjustment of Tariff of Fees, rates tendered and provisional sum allowances allowed for in the activity schedule will be adjusted as a contractual obligation in terms of the NDPWI Project Management Delegations where provision was made in the activity schedule, subject to approval in accordance with C2.1.3.2:

C2.2.2 Activity Schedule for Value-based Fees applicable to this tender.

C2.2.2.1 The tender submitted shall be based on the 2023 NDPWI - Scope of Engineering Services and Tariff of Fees. The tenderer must make provision for all activities necessary for the execution of the service as set out in Scope of Services (C 3) hereof.

C2.2.2.2 The estimated normal fees for full services indicated in the Activity Schedule [ C2.2.2.4 Column (a)] have been calculated in the following manner:

- The estimated cost of the works (including all deductions that will not form part of the Service Provider's work) is defined in the Activity Schedule [C2.2.2.4, column (a)].
- The basic fees (primary and secondary fee) for the estimated normal services is based on the estimated cost of the works [C2.2.2.2 (a)], as described in the 2023 NDPWI - Scope of Engineering Services and Tariff of Fees, derived from Clause 4.2.2 (1) for Multi-disciplinary Projects, [Basic fees].
- Apply applicable increase/decrease factors applicable to the portions of work to the Basic Fees [C2.2.2.2 (b)] as described in the 2023 NDPWI - Scope of Engineering Services and Tariff of Fees in terms of Clause 4.2.2 (2) for Multi-disciplinary Projects , [Estimated normal fees].
- No allowance has been made in the estimated normal fees below for the additional services that have been specified in C3.3.2 or C3.3.3 to be included in the normal fees.
- The Service Provider to make additional allowances when tendering should the Service Provider deem the adjustment factors to be either too low or too high, by adjusting the percentage of normal fees tendered. The percentage of normal fees tendered shall not be adjusted where the respective cost of the works values to which the respective adjustment factors are applied, either increases or decreases.

C2.2.2.3 The tenderer shall make provision for all activities necessary for the execution of the service as set out in C3 Scope of Services specified hereof when tendering the percentage of normal fees.

The percentage of normal fees and fees tendered to be calculated as follows:

- The normal fees for full services shall be based on the estimated cost of the works as indicated in [C2.2.2.4, Column (a) - Sub-total 1 – Estimated cost of the works].
- Determine the basic fees (primary and secondary fees) for normal services based on the estimated cost of the works [C2.2.2.3 (a)], derived from Clause 4.2.2 (1) for Multi-disciplinary Projects, as described in the 2023 NDPWI - Scope of Engineering Services and Tariff of Fees [Sub-total 2].
- Apply applicable increase/decrease factors to Sub-total 2 in terms of Clause 4.2.2 (2) for Multi-disciplinary Projects, as described in the 2023 NDPWI - Scope of Engineering Services and Tariff of Fees [Sub-total 3].
- Take into account the cost of other additional services specified under C3.3.2 and C3.3.3, which does not increase the cost of the works where fees are deemed to be included in the normal fees [Sub-total 4].
- Determine the most financially viable fees required to render full services for the full Service Contract Period (C1.2.2 - 3.15.1 [CD]) in terms of in terms of the scope of work defined in C3 to be offered [Sub-total 5].

#### C3.1 Employer's objectives

This tender is for:

A Service Provider performing civil engineering work on **a multi-disciplinary project**.

#### C3.2 Description of the Services

The general descriptions of the services required are as defined in the 2023 NDPWI - Scope of Engineering Services and Tariff of Fees, (Annexure B).

Specific services required are set out in Section C3.3 Extent of Services as well as in the most recent publication of the Departmental: Manual for Civil Consulting Engineers. Should there be any discrepancies between this Tender Document and the Manual for Civil Consulting Engineers, the former shall take precedence.

##### C3.2.1 Compilation of bills of quantities

##### C3.2.2 Project description

The Kinkelbos Police Station is situated in Kinkelbos, on Portion 4 of Farm 301, about 50 kilometres from Port Elizabeth, within the Sarah Baartman District Municipality, along the N2 Main Road. Over time, the facility has deteriorated significantly, resulting in an urgent need for refurbishment to ensure the continued safety, functionality, and operational readiness of the station.

##### C3.2.2.1 Scope

The scope of work involves condition-based maintenance and upgrades to various civil, electrical, and structural components across the facility. This includes internal areas such as the kitchen, administration offices, holding cells, vehicle safeguard section, fuel stores, and vehicle yard. External areas include access roads, the parking lot, outside toilets, and storm water infrastructure. The project also entails the replacement of the security fence, upgrades to the water and sewer reticulation systems, and storm water improvements.

A comprehensive condition assessment further revealed additional critical issues that need to be addressed. These include the need for asbestos roof replacements, generator replacement, and extensive repairs and renovations to outside buildings, prefabricated units, paving, walkways, ramps, covered parking areas, and temporary accommodation (decanting).

- a) Cell phones, including rental and call charges.

- b) All safety equipment for supervisory staff in accordance with the OHS requirements (e.g. safety jackets, boots, etc).
- c) All equipment including copier rental, fax machine, consumables, stationary, digital camera, etc.
- d) All necessary computer hardware, software, printers and modems and associated consumables.
- e) Any other items necessary for the capture of all relevant data required for administrating the contract and reporting to the Employer. One landline, including rental and call costs for work related office to fax usage shall be provided through the Works Contract.

(iii) Transport for site staff. The Service Provider shall provide sufficient appropriate vehicles on site for site staff.

C3.3.2.3 Occupational Health and Safety Act, 1993 (Act No. 85 of 1993) (Clause 3.3.3 Tariff of Fees):  
The Employer shall appoint a Service Provider under a separate contract as its "agent" as contemplated in the Construction Regulations to the Occupational Health and Safety Act, 1993 (Act 85 of 1993).

The Service Provider under this contract shall however make provision for the incorporation of the Occupational Health and Safety specifications, compiled by others, in the tender documentation, if applicable.

It is a firm requirement that in the designs, planning and supervision of the execution of the work done under the contract resulting from this tender, all applicable regulations and stipulations under OH&SA, (Act 85 of 1993) including regulations and codes of practice etc are complied with and that the final product shall be in full compliance with said legislation, standards, etc.

Furthermore, the Service Provider shall be fully responsible for the compliance of his operation, equipment as well as staff and persons under his supervision on site whether by invitation instruction or otherwise and regardless of the capacity, purpose and relationship of any such persons to the appointment, to all aspects of all applicable regulations and stipulations under OH&SA, (Act 85 of 1993).

C3.3.2.4 Quality Assurance System (Clause 3.3.4 Tariff of Fees) is not applicable

C3.3.2.5 Lead Consulting Engineer (Clause 3.3.5 Tariff of Fees is not applicable

C3.3.2.6 Principal Agent of the Client (Clause 3.3.6 Tariff of Fees and C3.5.1) is not applicable

Should this appointment be to also act as principal agent, over and above those as a civil engineer, the duties will *inter alia* include:

- receiving of instructions from the Departmental Project Manager (T1.1.4) and distributing to the relevant parties;
- co-ordinating of consultants;
- compiling and updating the planning programme;
- co-ordinating and arranging site meetings and inspections;
- liaising with client department only if specifically, so instructed;
- close liaising and co-operating with the Departmental Project Manager (T1.1.4);
- furnishing of monthly project reports;
- issuing of written instructions;
- receiving notices according to the building contract;
- issuing of monthly interim payment certificates, final payment certificates for practical and final completion;



- making recommendations in respect of the extension of the building contract period and periods where penalties are applicable;
- ensuring that all final accounts will be corrected and handed in on time;
- administering of and supervising the building contract in accordance with the requirements, where applicable, as set out in Manual for Private Architects PW 147, Section E; and
- other duties not listed above but which could reasonably be expected of a principal agent as well as those listed in the applicable Published Tariff of Fees .

#### C3.3.2.7 Environmental Impact Assessment is not applicable

The Service Provider is required to lodge an application on behalf of the Employer in compliance with the Environmental Impact Assessment Regulations: Regulations 1182 and 1183 of the Environmental Conservation Act, 1989 (Act 73 of 1989) for the proposed construction of the project. The Service Provider is furthermore required to compile a specification setting out the minimum requirements regarding the Environmental Management Plan (EMP) for the construction process, evaluate and approve the Service Providers EMP, and monitor his adherence thereto.

#### C3.3.2.8 Labour-Intensive Works applicable to civil engineering work:

The design and implementation of the construction/maintenance works must be in accordance with the latest version (download at [www.epwp.gov.za](http://www.epwp.gov.za)) of the Guidelines for the Implementation of the Labour-Intensive Projects under the Expanded Public Works & Infrastructure Programme (EPWP) published by the Department of Public Works & Infrastructure. The Service Provider must sign the undertaking (Appendix E of the Guidelines for the Implementation of Labour-Intensive Infrastructure Projects under the Expanded Public Works & Infrastructure Programme (EPWP)) confirming they have complied with EPWP requirements at design and implementation stages.

On multi-disciplinary projects the appointed quantity surveyor or on engineering projects the engineer shall perform the following services:

- a) Labour-intensive works when applicable, to be indicated with a "LI" in the Bills of Quantities descriptions.
- b) The Service Provider shall, for monitoring purposes, verify information and keep monthly records as received from the Contractor and transmit to the Employer via the Principal Agent, data on the following indicators with regard to the Project:

  - Actual Project Expenditure and actual output according to EPWP requirements;
  - Planned and achieved labour intensity;
  - Number of work opportunities created;
  - Demographics of workers employed (disaggregated by women, youth and persons with disabilities);
  - Wage rate earned on project;
  - Number of person-days of employment created;
  - Copies of Identity documents of workers;
  - Number of persons who have attended training including the nature and duration of training provided;
  - Assets created, rehabilitated or maintained in accordance with indicators in the EPWP M & E Framework;
  - Services provided or delivered in accordance with indicators in the EPWP M & E Framework



- c) The values for the indicators shall be submitted to the Employer according to agreed time frames on the prescribed reporting template (from the EPWP Unit in the Department of Public Works & Infrastructure) and obtainable from [www.epwp.gov.za](http://www.epwp.gov.za).
- d) The Service Provider shall, before certifying a Service Provider's (Contractor's) payment certificate, ensure that the Service Provider has submitted labour information in a format and timeframe specified by the Employer. If the information submitted by the Service Provider is inadequate the Service Provider shall not submit the payment certificate to the Employer for payment of the relevant outputs.
- e) The Service Provider shall certify that the works have been completed in accordance with the requirements of the Guidelines for the Implementation of Labour-Intensive Infrastructure Projects under the Expanded Public Works & Infrastructure Programme (EPWP) and the Contract:
  - whenever a payment certificate is presented to the Departmental Project Manager (T1.1.4) for payment; and
  - immediately after the issuing of a practical completion certificate that signifies that the whole of the works has reached a state of readiness for occupation or use for the purposes intended although some minor work may be outstanding.

#### C3.3.3 Additional Services (Other)

The Employer may order duties that fall outside the scope of the project as tendered. Such additional duties may involve, but not limited to:

- a) Additional design requirements not increasing the cost of the works after Sketch Plan approval
- b) Evaluation of alternative tenders
- c) Additional investigations during the Defects and Liability Period
- d) Diverse other services

Changing specifications and/or substituting materials for whatever reason does not constitute an additional service, but part of the design process.

The Service Provider shall be remunerated in terms of C2.1.3.6.1(c iii) subject to the approval in accordance with C2.1.3.2 (e to g) prior to executing the additional services.

#### C3.3.4 Supplementary Services: Administration of Contract Participation Goals

Administration of Contract Participation Goals is not required for this service.

Where applicable and the engineer has been appointed as the Principal Agent without a PQs, the Engineer shall source information pertaining to Local Material Manufacturers and Local Material Suppliers, and compile a Feasibility Study to determine which CPGs are implementable on the project. The Social Facilitator, if appointed will provide a database of beneficiaries of the CPGs. Where a Social Facilitator is not appointed, the Engineer must source all the relevant information. The engineer shall submit monthly reports on achievement of the CPGs based on information submitted by the Contractor, including substantiating documentation.

Where applicable and the engineer is appointed as the Principal Agent as well as a PQS, the PQS shall source information pertaining to Local Material Manufacturers and Local Material Suppliers, and compilation of Feasibility Study to determine which CPGs are implementable. The Social Facilitator, if appointed will provide a database of beneficiaries of the CPGs. Where a Social Facilitator is not appointed, the PQS must source all the relevant information. The PQS shall submit monthly reports on achievement of the CPGs based on information submitted by the Contractor, including substantiating documentation.

The service provider shall be remunerated in accordance with C2.1.9.

### C3.4 Use of reasonable skill and care

It will be expected of the Service Provider to apply reasonable skills and due diligence in the execution of the duties stipulated in this document which shall include *inter alia* the following:

Although the Service Provider's documents may be scrutinised by the Employer, this shall in no way relieve him of his professional responsibility for the proper and prompt execution of his duties. The Employer shall also be entitled to have any documentation or calculations verified by Others. In the event of mal performance, default or negligence, the Employer shall have the right to claim compensation or damages and set off such against any amount payable.

During assessment of any existing facilities, which may have a direct bearing on the Project, the Service Provider shall determine deficiencies with such facilities in terms of the Occupational Health and Safety Act, 1993 (Act 85 of 1993), the SANS 10400, etc. and recommend measures to rectify those during the project execution phase.

The Departmental Project Manager (T1.1.4) shall be notified by the Service Provider and his personnel of any transgression of *inter alia* the Occupational Health and Safety Act, 1993 (Act 85 of 1993) and environmental legislation during the Service Provider's operation pertaining to the Contract regardless of who may be involved.

### C3.5 Co-operation with other services providers

It will be required of the Service Provider to co-operate with the following:

#### C3.5.1 Service Providers

The required professional services will be executed by the professional team under the control and management of the designated Departmental Project Manager (T1.1.4) who, at the time of invitation to perform professional services, will be the person mentioned in T1.1.4. The Employer reserves the right to replace the mentioned Departmental Project Manager (T1.1.4) with another member of its staff or any individual/firm from the private sector should it be deemed necessary at any stage during the execution of the Project.

#### C3.5.2 Other role players

Local, provincial and national authorities, statutory bodies, governmental departments, Others, as may be required from time to time, including the client department/end user(s).

### C3.6 Brief

#### C3.6.1 Target dates and times

The Service Provider will be expected throughout to give preference to the execution of the work involved in this commission.

The work of all Service Providers will be co-ordinated by the principal agent. All work is to be performed by the persons listed as Key Persons and persons under their supervision and further be executed as described in the Programme according to Clause C1.2.2 - 3.15 [CD] (and/or PEP according to the same Clause, if applicable).

During the construction phase of the Project it will be expected of the principal agent to obtain a construction programme from the main Service Provider to continuously monitor his progress against that programme for compliance and to take whichever steps have been described in the relevant manual and the Working Guideline for Project Managers. This should be done in collaboration with the rest of the professional team, should the progress not be according to the said programme.

Where a Principal Agent / Principal Engineer or if a Quantity Surveyor has been appointed, the Quantity Surveyor, shall prepare the final account in consultation with the Employer and issue the final account to the contractor within sixty (60) working days from the date of Practical Completion. Late completion of final account will result in penalties being applied per calendar day, as tabled under Clause C1.2.2 - 3.12 [CD].

#### C3.6.2 Reporting requirements and Approval Procedure

Notwithstanding any other requirements as listed elsewhere, the Service Provider shall submit a monthly report indicating progress of the Services.

#### C3.6.3 Local content

It is the policy of the Employer to give preference to materials and equipment of South African manufacture. The Service Provider is to ensure that, wherever feasible, designs are based on locally manufactured equipment and materials which can meet requirements at competitive prices.

#### C3.6.4 Design innovation

Given the need for energy efficiency and environmental sustainability in the built environment, each member of the professional team, is required, wherever possible and applicable, to demonstrate design innovation in all aspects of the Service towards “green” design solutions. Aspects to be considered and incorporated in all new building and/or maintenance designs are, *inter alia* but not limited to,

- (a) sustainable development  
e.g. in building form, material choice, construction detailing and methods, recycling ability;
- (b) energy efficiency e.g.:
  - (i) passive design methods towards energy conservation and consumption: building orientation, exploitation of nature’s inherent energy sources),
  - (ii) energy efficient solutions and installations for lighting, ventilation, cooling, heating, etc. (e.g. energy efficient light fittings),
  - (iii) alternative or renewable energy sources where practical/feasible/economical;
- (c) water conservation/saving/re-use methods; and
- (d) environmental friendliness (e.g. respect for natural habitat, blending of building with site/environment/surrounding fabric, positioning of buildings, consideration of neighbouring sites’ access to sun, wind, view, etc.).

#### C3.6.5 Final disposal of documents

Upon approval and finalisation of the final account of projects requiring a security clearance, it is a requirement that the Service Provider forward to the Employer all documents relating to this service. The same may also be requested on projects not requiring a security clearance.

### C3.7 Applicable legislation and standards

This section applies to legislation emanating from national and provincial governments as well as that of any local authorities in whose area of jurisdiction the subject of the appointment falls and which has a bearing on the activities and facilities under this appointment.

All the applicable legislation, which do not specifically allow discretion in respect of compliance by the State, shall be followed exactly as intended by such legislation regardless of any instructions, verbal or in writing, to the contrary. (Refer *inter alia* to Section 41 of the Occupational Health and Safety Act, 1993 (Act 85 of 1993)).

Should any applicable legislation allow discretion in respect of compliance by the State, it shall be followed exactly as intended by the relevant legislation as if no discretion is allowed until such time as specific instructions in writing are issued to the appointed professional team by the Departmental Project Manager (T1.1.4).

The Service Provider undertakes to ensure that his actions and outcome thereof including, but not limited to, the facilities to be affected by the Service shall be in accordance with all relevant legislation and upon delivery, will function as required by said relevant legislation. The Service Provider's actions and the outcome thereof will in no way be detrimental to the health and safety of the occupants or persons present therein or in the vicinity thereof. Similarly, it must not be detrimental to any aspects of the environment in its structure or operation if operated as specified in operation manual(s). The relevant legislation meant herein, as amended, consist of *inter alia* the following, but not limited to:

- Atmospheric Pollution Prevention Act, 1965 (Act 45 of 1965);
- Construction Industry Development Board Act, 2000 (Act 38 of 2000);
- Council for the Built Environment Act, 2000 (Act 43 of 2000);
- Electricity Act, 1987 (Act 41 of 1987);
- Engineering Profession Act, 2000 (Act 46 of 2000);
- Environmental Conservation Act, 1989 (Act 73 of 1989);
- Fire Brigade Services Act, 1987 (Act 99 of 1987);
- Local Government Municipal Systems Act, 2000 (Act 32 of 2000), municipal by-laws and any special requirements of the local service supply authority;
- National Building Regulations and Building Standards Act, 1977 (Act 103 of 1977);
- National Environmental Management Act, 1998 (Act 107 of 1998);
- National Heritage Resources Act, 1999 (Act 25 of 1999);
- National Water Act, 1998 (Act 36 of 1998);
- Occupational Health and Safety Act, 1993 (Act 85 of 1993);
- Telecommunications Act, 1996 (Act 103 of 1996);
- Water Services Act, 1997 (Act 108 of 1997) and general authorizations;
- the latest issue of SANS 10142: "Code of Practice for the Wiring of Premises";
- the Regulations of the local Gas Board, where applicable and
- all regulations promulgated under the above Acts.

Although the more salient legislation has been referred to above, the *onus* remains on the Service Provider to adhere to, and apply, any and all Acts and/or Regulations not specifically mentioned in the list above but which will have an effect on the Project.

This will be a continuous process throughout the appointment, which will manifest itself during the following phases:

- development of plans and documentation;
- supervision of any Service Providers under the appointment;
- ensuring compliance of the end product;
- compiling and issuing of Instruction/Operational Manuals indicating *inter alia* what the legal and safety requirements entail for the user(s)/operator(s) of the facilities;
- providing instruction to the intended users/operators.

The Service Provider accepts full and complete responsibility (both contractually and/or in delict) regarding compliance with the Occupational Health and Safety Act, 1993 (Act 85 of 1993) for his acts and omissions as well as those of his employees and indemnifies the Employer against any legal action in this regard.

The Service Provider undertakes to ensure that the requirements of the Occupational Health and Safety Act, 1993 will similarly apply to the agreement with any sub Service Providers inclusive of indemnifying the Employer against any legal action regarding the actions and/or omissions by them.

### **C3.8 Access to land/buildings/sites**

Access to the land/buildings/sites shall be negotiated in consultation with the Departmental Project Manager (T1.1.4).

### **C3.9 Software application for programming**

The Service Provider must avail himself of software to be used in the Project documentation for compatibility with other Service Providers as well as the Employer. Specific requirements for compatibility are specified in the relevant manuals.

### **C3.10 Security clearance**

It is an explicit condition of this agreement that partners, directors and/or the members of staff who will have insight into the planning of projects requiring security clearance, be kept to a minimum and that such persons will not object to being submitted to a security clearance, if the Employer so requires.

If the latter is applicable, the necessary forms will accompany this tender or be provided to the Service Provider at any stage thereafter. These forms must be completed, if attached, and returned with the tender. It is important to furnish information which is complete in every respect.

Should the authority responsible for the clearance, for security reasons not be satisfied with the classification obtained of any of the staff members of the Service Provider, it will be a further condition of this appointment that none of such staff members be involved with any aspect of the Project.

All documents pertaining to these projects must be stored in a safe place when not in use so as to ensure that the level of security of the projects is maintained.

The Employer will not accept liability for any costs in this regard.

FINGER PRINTS (except Defence projects)

Persons of whom security clearance is required can obtain a finger print form SAP 91(a) from any police station. Kindly ensure that the police official responsible for taking the finger prints certifies the form since non-certification will result in the form being unacceptable.

### **C3.11 Forms for contract administration**

All forms required during contract administration, called PRM forms, are available on the Employer's website at <http://www.publicworks.gov.za> under "Documents"; "Consultants Guidelines"; item 14. The agreement and conditions of contract to be entered into with the main Service Provider shall be the most recent version of the JBCC, if it is a multi-disciplinary contract, or GCC, if it is an engineering contract, or the NEC suite of contracts, or the FIDIC suite of contracts, or any other form of contract **as approved and in use by the National Department of Public Works & Infrastructure.**

### **C3.12 Condition to accept unregistered persons with suitable built environment qualifications on secondment**

It is an express term of the contract that the Service Provider, after award of tender, accept unregistered, suitably qualified (built environment) persons in his office for the purpose of exposing the latter to the full extent of professional work, or as may be required according to specific circumstances, in order to gain experience which can be presented to the relevant Council for consideration towards professional registration. The secondment of such unregistered persons will be negotiated with the Service Provider in terms of numbers, periods of training and extent of professional work opportunity to be afforded. The conditions of secondment will be the subject of a separate Memorandum of Understanding with the Service Provider which will serve as an annexure hereto. Any secondment arrangements will cease upon the professional registration of the seconded person or as agreed on and so included in the aforesaid Memorandum of Understanding. The responsibility for salaries of seconded persons will remain with the Employer, but responsibility for operational expenses, necessary for the execution of the work, will vest with the Service Provider, all of which will be dealt with in the Memorandum of Understanding.



### C3.13 Submission of Accrual Reports

The Service Provider shall submit accrual reports to the client representative at the end of March and September each year for the duration of the Service Contract Period (C1.2.2 - 3.15.1 [CD]) from the date of appointment up to and including project closeout. This is to ensure that PMTE complies with the accounting framework GRAP, which requires that PMTE disclose all its accruals as at the end of each reporting date.

### C3.14 Submission of monthly updated Project Execution Plans (PEP)

The Principle Agent will submit monthly, an updated Project Execution Plans (PEP) in accordance with DPWI standard proforma in MS Project format, on a date as agreed with the Departmental Project Manager (T1.1.4).

### C3.15 Contract Skills Development Goal

The Contract Skills Development Goal is not applicable to this project.

The cidb Standard for Developing Skills through Infrastructure Contracts as published in the Government Gazette Notice, No. 48491 of 28 April 2023 where the Service Contract has a duration of 12 months or more, and the professional fees excluding allowances and including VAT exceeds R5 million. This best practice Standard for developing skills through infrastructure contracts standard establishes a minimum contract skills development goal which is to be achieved in the performance of a contract in relation to the provision of different types of workplace opportunities linked to work associated with a contract which culminate in or lead to registration in a professional category by one of the professional bodies listed in the standard (Table 1).

The Contract Skills Development Goal (CSDG) is the number of hours of skills development opportunities that a Service Provider contracts to provide in relation to work directly related to the Service Contract up to completion the Professional Service Contract. The contract skills development goals, expressed in hours, shall be not less than the professional fees [(1) from the Activity Schedule + VAT] in millions of Rand multiplied by 150 where professional fees is the financial value of a professional service contract at the time of the award of the contract excluding all allowances and expenses, but including value added tax.

Example: The contract amount for a professional services contract is R5.6 m. The contract skills development goal in hours is  $R5.6m \times 150 = 840$  hours, where the contract amount is the basic fee for services excluding allowances but including VAT.

Where required in terms of the service contract, a specified proportion of the learners and candidates shall be selected from persons in the employ of the state who meet the relevant eligibility criteria for the relevant programme.

Method 2: structured workplace learning opportunities for apprentices or other artisan learners towards the attainment of a trade qualification leading to a listed trade (GG No. 35625, 31 August 2012) subject to at least 60% of the artisan learners being holders of public TVET college qualifications;

Method 3: work integrated learning opportunities for University of Technology or Comprehensive University students completing their national diplomas; or

Method 4: structured workplace learning opportunities for candidates towards registration in a professional category by a statutory council listed in Table 1 above.

Employed learners may not account for more than 33 percent of the contract skills development goal. Not more than one method may be applied to any individual concurrently in the calculation of the contract skills development goal. The principle is that an individual can only be counted once towards the CSDG.

Not more than one method may be applied to any individual concurrently in the calculation of the contract skills development goal.

### **Contract Skills Development Goal Credits**

Contract skills development credits will not be awarded for learners enrolled as beneficiaries of other funded or subsidised programmes.

In the case of engineering and construction works, design and build and services

contracts:

- The contract skills development goals shall be granted by multiplying the number of people employed by the Service Providers and placed for continuous training opportunities in a three-month period by the notional values contained in Table 3, or as revised in a Gazette notice.
- The Service Provider may source beneficiaries of the contract skills development goal from the cidb Skills Development Agency (SDA).
- All beneficiaries of the Standard must be registered with the cidb SDA.

NOTE: The role to function of a cidb SDA is outlined in the Standard, Annexure B.

Credits towards the contract skills development goal for professional services contracts shall be granted by summing the hours of structured workplace learning opportunities provided to P1 and P2 learners as well as professional candidates in accordance with the Act, Clause 3.3.

No more than 45 hours may be claimed per week for any individual.

Contract skills development goal credits shall be reduced to the extent that they fail to comply with the requirements of this standard.

The Service Provider shall achieve in the performance of the contract the contract skills development goal established in this Standard for developing skills through infrastructure contracts (March 2020).

\* Additional provisions include provisions for personal protective equipment, insurance, medical assessments, course fees and trade tools (where applicable) assessment, moderation and monitoring of learners.

**NOTE:**

- Where an unemployed learner is employed directly by the Service Provider, the Service Provider shall pay the stipend directly to the learner
- Where an unemployed learner is sourced through an SDA, training provider or skills development facilitator the Service Provider must pay the stipend to the SDA, training provider or skills development facilitator who in turn will pay the learner
- The notional cost of providing training opportunities will be increase by CPI on an annual basis. The new, revised costs will be published on the cidb website on 1 April in each year.



The Employer requires that employees of the state be seconded to the Service Provider in order to be provided with structured workplace learning opportunities in accordance with the provisions of this standard. The specified number of employees of the state is **N/A**. The Employer shall provide a list of persons for selection by the Service Provider as prescribed in the implementation guidelines. Persons selected by the Service Provider shall be seconded to the Service Provider under the terms and conditions prescribed in the implementation guidelines.

Where the contract is part of a Strategic Infrastructure Project (SIPs) the Service Provider will be required to report to the Presidential Infrastructure Coordinating Council through the respective SIP Skills Coordinators linked to the office of the SIP Coordinator, using the approved PICC reporting template.

Credits towards the contract skills development goal shall be denied where the Service Provider fails to comply in terms of Clause 3.4 of the Act. Compliance requirements shall be in terms of Clause 4 of the Act and records to be provided to be in accordance with Clause 5 of the Act.

### **Role and functions of the Skills Development Agency**

The Skills Development Agency (SDA) will provide career management and compliance reporting functions for all learners for CSDG compliance in terms of this Standard. Where the Service Providers provide direct employment to unemployed learners, or enrolls own employees for CSDG compliance, the Service Provider shall register them with the cidb SDA. The SDA can also act as an employment intermediary for unemployed learners.

The roles and functions of the Skills Development Agency (SDA) are summarised below.

#### **Career Management and Compliance Reporting**

The Service Provider shall enter into a contract agreement with the cidb SDA, training provider or skills development facilitator to manage their learners according to the provisions given below:

- a) preparing training plans for registered learners, including details of the scope of experiential work to be covered and expected outcomes;
- b) registering learners with the appropriate Sector Educational and Training Authority established in terms of the Skills Development Act of 2008 (Act 37 of 2008);
- c) conducting entry and exit level medicals for learners at the conclusion of each placement opportunity;
- d) providing personal protective equipment;
- e) liaising with the supervisor to monitor onsite training progress of learners;
- f) liaising with the supervisor to arrange for summative assessments at appropriate stages of the training; and
- g) liaising with the supervisor to prepare reports for the Departmental Project Manager (T1.1.4) and cidb at practical completion of the contract.

The relevant training provider or skills development facilitator shall invoice the Service Providers for the provision of these services as per cost schedule in Table 3.

The cidb SDA shall open a trust fund to ring-fence monies essential for all learner requirements where necessary provided for in this standard such as personal protective equipment, medical assessments, insurance, course fees, monitoring as well as top up training and assessment.

#### **Employment Intermediary**

The cidb SDA can act as an employment intermediary for unemployed learners and provide Service Providers with learners qualifying for participation in the CSDG, as well as managing their employment functions such as payment of stipends, workman's compensation, provision of personal protective equipment, trade specific tools, etc.

In such cases, the Service Provider shall contract directly with an SDA, training provider or skills development facilitator of their choice for the recruitment, placement and management of learners. The

Service Provider shall pay the SDA, training provider or skills development facilitator in accordance with the notional costs provided for in this standard, or as amended by a Gazette.

### **Sanctions**

Failure by the Service Provider to achieve the **total** Notional Cost of the Contract Skills Development Goal (Excluding VAT), as indicated in the pricing schedule item, will result in a penalty of 30% of the value of the portion not achieved, unless the Service Provider can prove to the Employer's satisfaction that the non-achievement was beyond his/her control.

### **C3.16 Co-funded projects**

Co-funding of Capital Works by the End-user Client is not applicable to this project.

When applicable, the service provider shall render the following services distinguishing between Repairs & Renovations and Capital Works / Co-funded portions of the Works respectively:

- a) Issue two separate monthly evaluations (if no PQS has been appointed);
- b) Issue two separate monthly payment certificates (if appointed as Principal Agent);
- c) Issue one monthly progress report with summary report distinguishing between Repairs & Renovations and Capital Works / Co-funded portions of the Works;
- d) Issue one monthly financial status report and cash flows with one summary report distinguishing between Repairs & Renovations and Capital Works / Co-funded portions of the Works for both Contractor and Consultants (if no PQS has been appointed);
- e) Final account to differentiate between Repairs & Renovations and Capital Works / Co-funded portions of the Works with apportioned CPAP (if no PQS has been appointed); and
- f) Submit two separate quarterly consultant fee invoices for services rendered by the Service Provider apportioned between Repairs & Renovations and Capital Works / Co-funded portions of the Works respectively, including P&Gs.

The Service provider shall be remunerated in accordance with C2.1.10 above.

## **SPECIAL CONDITIONS OF BID FOR INFRASTRUCTURE PROCUREMENT**

### **1 INTERPRETATION**

- 1.1 The word "Bidder" in these conditions shall mean and include any firm of Contractors, Services Providers or any company or body incorporated or unincorporated or any other legal entities.
- 1.2 The word "Department" in these conditions shall mean the DEPARTMENT OF PUBLIC WORKS AND INFRASTRUCTURE
- 1.3 Any reference to words "Bid" or "bidder" herein and or any other documentation shall be construed to have the meaning as the words "Tender" or Tenderer".

### **2 PRECEDENCE**

- 2.1. If any other condition (bid rule) in the bid document is in contradiction with the "Special Conditions of Bid" the "Special Conditions of Bid" will take preference.
- 2.2. The "Special Conditions of Bid" can only be amended by an official addendum before the closing date of the bid.

### **3 GENERAL BID RULES**

- 3.1. "Written" or "in writing" means hand-written in non-erasable ink or any form of electronic or digital writing and or a combination thereof.
- 3.2. The digital and or electronic completion and signing of documents is permitted.
- 3.3. A bidder participates in this bid process entirely at its own risk and cost.
- 3.4. The Department may accept or reject any bid offer or may cancel the bid process (or reject all bid offers at any time) prior to award, due to the following:
  - 3.4.1. due to changed circumstances, there is no longer a need for the goods or services specified in the invitation;
  - 3.4.2. funds are no longer available to cover the total envisaged expenditure;
  - 3.4.3. no acceptable tender is received;
  - 3.4.4. there is a material irregularity in the tender process; or
  - 3.4.5. there is material change in the scope of works.
- 3.5. The Department shall not accept or incur any liability for such cancellation or rejection or acceptance, but will give written reasons for such action upon receiving a written request to do so.
- 3.6. Completed bid documents in a sealed envelope, endorsed with the relevant bid number, bid description and the closing, must be deposited in the bid box as indicated in the bid document.
- 3.7. Bidders must ensure that bids submitted via courier services are deposited by the courier service in the Departmental Bid box, prior to the closing date and time. The Department will not accept responsibility for any bids, which are not timeously deposited in the Bid Box.
- 3.8. A Bid will be treated as a late bid, if it is not received in the bid box. The Department will not accept responsibility for any late depositing of bids or for the non-depositing of bids in the bid box, which are as a result from an act committed or omitted by an official. This is not limited to the following cases:
  - 3.8.1. A Bidder handed over its bid to a departmental official or to the security services personnel timeously, but they omits to deposit the bid in the bid box on or before the closing date and time.
  - 3.8.2. If a courier service delivers the bid to a departmental official or to the security services personnel timeously and it is not deposited in the bid box timeously.
  - 3.8.3. The bid documents were send through mail / Post Office and it is not timely collected and or timely deposited in the Departmental Bid Box.
- 3.9. Bids received after the closing date and time will not be accepted for consideration and where practical, be returned unopened to the Bidder(s).
- 3.10. Bidders who are not registered on the CSD, must register on the CSD within 7 working days, if requested to do so. No award letters or purchase orders or contracts will be signed, with a bidder not registered on the CSD.
- 3.11. The Department will download the following documents, to verify the information submitted by bidders:
  - 3.11.1. CSD registration certificate (if the bidder is registered in the CSD)



- 3.11.2. CIPC registration
- 3.11.3. CIDB registration
- 3.12. Bidders are not allowed to recruit or shall not attempt to recruit an employee of the Department for purposes of preparation of the bid or for the duration of the execution of this contract or any part thereof.

#### **4 AMBIGUITIES/ CONTRADICTIONS / OMISSIONS**

- 4.1. If a bidder becomes aware of any ambiguities or contradictions or omissions in the bid document or the specifications, drawings or descriptions or functionality or quality, or any part of the bid document, this should be clarified with the Department, at least five (5) working days before the closing time stated in the tender data.
- 4.2. If the Department found, after the closing date of the bid, that there is an ambiguity/ contradiction or omission in the bid document , the Department reserves the right to:
  - 4.2.1. If the ambiguity or contradiction or omission in the bid document is of an administrative nature, request bidders to correct any non-compliances caused by the ambiguity or contradiction or omission or
  - 4.2.2. If the ambiguity or contradiction or omission is immaterial, proceed to finalise the procurement process and notify the delegated authority in the submission of the ambiguity or contradiction or omission for the consideration of the approving authority or
  - 4.2.3. Cancel the bid and process

#### **5 PERIOD OF VALIDITY FOR BIDS AFTER CLOSING DATE**

- 5.1 All Bids must remain valid from the closing date for a period as stipulated in the bid document.
- 5.2 The Department reserves the right to request for the validity extensions of bids, should it deemed necessary. The following conditions will apply when the Department request for a validity extension of a bid:
  - 5.2.1 The request for a validity extension will be done while the validity period of the bids are still valid.
  - 5.2.2 Bidders have the right to refuse the extension of the validity period of their bids.
  - 5.2.3 If a request for validity extensions are send to bidders while the validity period of the bids are still valid, non-replying to the request for validity extension before the expiry date will be deemed a tacit agreement to the extension of the validity period. The Department will communicate with the affected bidders to confirm such tacit agreement.
  - 5.2.4 Should the bidder not agree with the tacit agreement, the bidder shall be deemed to be non-responsive and not considered for further evaluation.
  - 5.2.5 If a bidder(s) refused a validity extension, it will be deemed that the bidder(s) had withdrawn their bids from the bidding process. The Department reserves the right to continue with its bid evaluation and adjudication of the remaining bids and finalise the process.

#### **6 BRAND NAMES**

- 6.1 Wherever a brand name is specified in this bid document (i.e. in the specifications, pricing schedule or bill of quantities or anywhere in this document), the department's requirement is not limited to the specified brand name, but requires an item similar/equivalent or better than specified.

#### **7 CONTRACTUAL PRICE ADJUSTMENTS**

- 7.1 The Bid will not be subjected to any price escalation, unless specified otherwise in the bid documents.

#### **8 AUTHORITY TO SIGN BID DOCUMENTS**

- 8.1 No authority to sign (PA 15.1: Resolution of Board of Directors) is required from an enterprise which has only one director or is a sole ownership.
- 8.2 In the case of a bid being submitted on behalf of a company, close corporation or partnership, evidence should be submitted with the bid at the closing time, that the Bid has been signed by a person properly authorised by resolution of the directors or under the articles of the entity. For that





purpose, forms PA-15.1-15.3 (Resolution of Board of Directors) are included in the bid document for completion by the relevant Board(s) of Directors

- 8.3 The department further accepts that, in the absence of a PA 15.1: Resolution of Board of Directors, any director or any member of the enterprise may have the authority to bind the enterprise. Therefore the following will apply when only one director or one member of the enterprise signed the bid documents:
- 8.3.1 The signature of any one of the directors or any one of the members of the enterprise will bind the enterprise and all the directors/ members of the enterprise. This condition will therefore render the bid valid; and
- 8.3.2 The Department will verify the authority to sign (if deemed necessary) and where possible, may request proof of such authority of the relevant director or relevant member to act on behalf of the enterprise in the form of a “Resolution of the Board of Directors”, if such “(PA 15.1: Resolution of Board of Directors),” was not submitted with the bid or was not completed or was incorrectly completed,
- 8.4 In the case of a sub-contractor agreement, a joint venture or consortia, the signing of the sub-contractor agreement, or Joint Venture or Consortia agreement by any director or member of each of the parties to the agreement, will render the sub-contractor agreement or Joint Venture or Consortia agreement valid. Therefore:
- 8.4.1 The Department reserves the right to request from each party to the sub-contractor agreement or Joint Venture or Consortia” agreement, proof of such authority of the relevant director or relevant member to act on behalf of the enterprise(s), in the form of a “Resolution of the Board of Directors”, if it was not submitted with the bid or was not completed or was incorrectly completed,
- 8.5 In the event that a non-member or non-director to the enterprise(s) sign the bid documents and or sign a joint venture or consortia agreement, an “Authority to sign” issued by a director of the enterprise(s) or by the Board of Directors of the enterprise(s) must be submitted with the bid at the closing date. Failure to comply with this requirement at the closing date of the bid, will invalidate the bid submitted.

## **9 CONTRACT PERIOD**

- 9.1 The contract period is stipulated in the Contract Data or the specifications.
- 9.2 The construction period for Infrastructure works, will commence from the date of site handover.

## **10 NEGOTIATION WITH THE IDENTIFIED PREFERRED BIDDER**

- 10.1 The Bid will be awarded to the bidder who scores the highest PPPFA number of points:
- 10.1.1 However, should an offer not be market related, the Department reserves the right to negotiate with bidders a reasonable market price /offer?

## **11 AWARD OF CONTRACTS TO TENDERERS NOT SCORING HIGHEST POINTS**

- 11.1 The Department reserves the right to award the bid to a tenderer not scoring the highest points, after having applied an objective criteria or a risk assessment criteria, if such (i.e. the objective criteria/ risk assessment) is specified in the bid document.

## **12 TAX COMPLIANCE**

- 12.1 No tender shall be awarded to a bidder who is non tax -compliant.
- 12.2 All bidders’ tax matters must be in order prior to award.
- 12.3 Bidders’ tax matters will be verified through CSD.
- 12.4 If the recommended bidder’s tax status is non-compliant, the recommended bidder must submit written proof from SARS of their tax compliant status or submit written proof that they have made an arrangement with SARS to meet their outstanding tax obligations.
- 12.5 The recommended bidder will be given a maximum of seven (7) working days to correct their tax compliance status.
- 12.6 Failure to comply within seven (7) working days, from the date of the request, the Department will reject the bid submitted by the bidder.

## **13 REGISTRATION AS A VAT-VENDOR**





- 13.1 Non-VAT vendors do not have to include VAT in their bid prices.
- 13.2 Non-VAT vendors who submit bids for contracts that would, if successful, take their annual turnover above the threshold of R1 million, must include VAT in the prices quoted and must therefore immediately upon award of the contract, register with the South African Revenue Service (SARS) as VAT vendors.
- 13.3 The award of contract would be conditional (for Non-VAT vendors who included VAT in their prices) conditional pending the successful bidder submitting proof of registration as VAT vendor with SARS within 21 days of award.
- 13.4 Failure to comply within 21 days after being notified to do so will lead to the automatic withdrawal of the “provisional letter of award” and elimination of the bidder’s offer.
- 13.5 VAT vendors must include VAT in their bid prices and failure to comply will lead to an automatic elimination of the bidder’s offer.
- 13.6 In all other instances, where bidders have excluded VAT from the prices quoted, if the bidder is successful, the letter of award will clearly state that the price at which the contract is awarded is exclusive of VAT and that VAT will not be added on at any stage after the contract has been signed.
- 13.7 If a Non-VAT vendor/ bidder is contracted with the Department with a price which is Excluded Vat, and it becomes a VAT vendor after award or alternatively becomes a VAT vendor due to a cumulative number of awards, the bidder will have to absorb the adverse financial implications of not including VAT in their price quoted. VAT cannot be claimed from the Department for any payments already made or from any future payments.



#### 14 CERTIFICATION OF DOCUMENTS

- 14.1 Where so required in the bid documents, bidders are required to submit copies, which are certified as a “true copy of the original”.
- 14.2 If a bidder submitted an uncertified copy of an original document, or an original copy which is not correctly certified, the bidder will be afforded an opportunity to correct such non-compliance within a minimum period of 48 hour.
- 14.3 All bidders’ whose copies complies with the minimum requirements above, will be “deemed in order” and will be subjected for consideration in further evaluation processes, even if the Department did not request any corrections.
- 14.4 No submissions of new or alternative documents or certified copies of new or alternative documents will be allowed after the bid closing date.
- 14.5 The Department will not accept a copy of a previously certified document and will not provide any bidder an opportunity to correct such a non-compliance.

#### 15 REQUIREMENTS FOR A VALID BBBEE CERTIFICATES AND SWORN AFFIDAVITS

- 15.1 A valid B-BBEE Certificate is a B-BBEE Certificate which has not expired at the closing date of the bid.
- 15.2 A “Sworn Affidavit” must comply with the following minimum requirements at the closing date, to be considered valid. If the submitted “Sworn Affidavit” does not comply with the minimum requirements below, the bidder will not be given an opportunity to correct it:
  - 15.2.1 The “Sworn Affidavit” must not be expired at the closing date.
  - 15.2.2 The BBBEE Level Contributor must be indicated (ticked)
  - 15.2.3 The “Sworn Affidavit” must be signed and dated by the bidder (Deponent).
  - 15.2.4 The “Sworn Affidavit” submitted must be signed and stamped by the “Commissioner of Oath”.
  - 15.2.5 The “latest financial year-end” field must not be left blank.
    - 15.2.5.1 The latest “financial year-end date” cannot be a future date.
    - 15.2.5.2 If only the year is indicated (it is not in the format: day/month/year), the Department will validate the financial year-end (day/month) from CIPC or deal with any clarity seeking matter/ confirmation as an administrative matter.
- 15.3 In respect of “Sworn Affidavits” of the Construction sector, Property Sector, the field (block) where the bidder must confirm its financial information (i.e. Net Assets or Annual Turnover) must be completed (ticked) and must not be left blank or not ticked.
- 15.4 The Commissioner of Oath cannot be an employee or ex officio of the enterprise because, a person cannot by law, commission a sworn affidavit in which they have an interest.
- 15.5 The Department will seek the following clarity matters in respect of the Sworn Affidavits (should it be deemed necessary) and upon request, the bidder will be given a minimum of five (5) working days to respond to the Department:
  - 15.5.1 If the bidder did not select/circle/ticked “Member/ Director/ Owner” where so required. The Department will communicate with such affected the bidder in writing.
  - 15.5.2 If a bidder did not select/ circle/ ticked the required field “Financial Statements/ Management Accounts/ Audited Financial Statements” where so required. The Department will communicate with such affected the bidder in writing.
  - 15.5.3 If only the year is indicated (it is not in the format: day/month/year), the Department will validate the financial year-end (day/month) on CIPC or against any other submitted document or will seek clarity / confirmation from the bidder and deal with it as an administrative matter.
  - 15.5.4 If the financial year-end indicated in the sworn affidavit is not at the end of the month or it is not the correct month when validated on CIPC or against any other submitted documents, the Department will enquire from the affected bidder to indicate its correct latest financial year end in the format (day/month/year) and:



- 15.5.4.1 If the “day” indicated on the submitted affidavit is wrong, but the month and year is correct, the bidder’s affidavit will be “deemed valid” and it will be evaluated.
- 15.5.4.2 If the “month” indicated on the submitted affidavit is wrong, the bidder’s affidavit will be considered invalid.
- 15.6 The Department will deal with all other matters, which is not listed under the minimum requirements as reflected above, as administrative matters, should it be deemed necessary.
- 15.7 For all sectors (example the construction sector, the property Sector and or any sector), a “Sworn Affidavit” issued in terms of the relevant sector must be used. All the minimum requirements applicable to “valid sworn affidavits” as per this “Special Conditions of Bid” will apply.

## **16 AWARDING OF POINTS FOR SPECIFIC GOALS (PA-16)**

- 16.1 In accordance with the PPPFA regulations 2022, bidders will not be eliminated if they do not submit a BBBEE – certificate or a “valid sworn affidavits”. The bidder will not be scored for points, but will be evaluated further.
- 16.2 For a bidder to be awarded points for specific goals as per the bid, the bidder must submit proof as specified in the bid document with the bid at the closing date and time.
- 16.3 The requirements of a valid BBBEE-Certificate and or “Sworn Affidavit” as specified in the Special Conditions of Tender applies.
- 16.4 Parties in an unincorporated joint venture must submit its own consolidated B-BBEE certificate, which has not expired at the closing date of the bid.
- 16.5 If a bidder submit with the bid at the closing date the required proof for specific goals, as specified in the bid document, but the proof is not certified or is certified incorrectly, the bidder will be given a minimum of 48 hours to submit a copy which is correctly certified. The copy maybe certified after the closing date of the bid. The copies maybe certified after the closing date of the bid.
- 16.6 Non-submission of the PA-16 form or non-completion the PA-16 form or an incomplete PA-16 form, is not an elimination criteria.
- 16.7 If a bidder submit at the closing date of the bid a valid proof as specified in the bid document, but the bidder’s PA 16 is not signed or dated or witnessed or it is not properly completed, or its not completed or submitted or did not claim points, the bidder will be given a minimum of 48 hours to submit or correctly complete its PA 16.
- 16.8 All bidders’ whose submitted proof as specified in the bid document and it complies with the minimum requirements above, will be “deemed in order” and will be subjected for consideration in further evaluation, even if the Department did not request any corrections/ certifications.
- 16.9 No submissions of alternative proof for specific goals as specified in the bid document will be allowed after the bid closing date.
- 16.10 Bidders who failed to submit the required proof for points for specific goals, will not be scored for the relevant specific goal(s), but there offers will still be evaluated further.

## **17 BIDDER’S DISCLOSURE/ BIDDER’S DECLARATION (PA - 11)**

- 17.1 The Department will afford a bidder an opportunity to correct its PA-11 form, if the bidder omitted to sign or to complete or to properly complete this form.
- 17.2 A bidder’s offer maybe eliminated if the bidder’s declaration is proven false during the bid evaluation process.

## **18 CORRECTION OF ERRORS**

- 18.1 Only the authorised signatory to the tender should initial corrections in the tender document.
- 18.2 All corrections must be in non-erasable ink and the use of correcting fluid (tippex) is prohibited.
- 18.3 In the event that a correction is not initialled or the correction is initialled by a person not having the prescribed authority, the Department will:
  - 18.3.1 Seek the necessary clarification from the tenderer and;
  - 18.3.2 If accepting the response from the tenderer, evaluate the bid further and or;

## 1. PREAMBLE

The **services** to be provided by the **consulting engineer** and the corresponding remuneration have been set out herein for projects implemented by or on behalf of the National Department of Public Works and Infrastructure.

The Scope of Services and Tariff of Fees described herein are generally applicable and are referred to in the **agreement**. Specific requirements with regards to the Scope of Services and the Tariff of Fees shall be set out in the **agreement** and should any requirement of the **agreement** be in conflict with the requirement of this document, the requirement of the Agreement shall prevail.

Any amount mentioned in or fee calculated in terms of this document is exclusive of Value Added Tax.

This document allows for four different methods of remuneration namely:

- (1) Fees for Normal Services (percentage fee based on the cost of works),
- (2) Fees for Additional Services (fees for services additional to those provided for in the Normal Services),
- (3) Time-based fees and
- (4) Expenses and costs.

Words or expressions in bold font are defined in Clause 2.2.

## 2. GENERAL PROVISIONS

### 2.1 GENERALITY OF TERMS

In this document, except where the context otherwise requires or indicates:

- (1) the masculine includes the feminine,
- (2) the singular includes the plural, and
- (3) any reference to a natural person includes a juristic person.

### 2.2 DEFINITIONS

In this Schedule, any word or expression defined in **the Act** has that meaning, unless the context otherwise indicates:

- (1) **Agreement** means the Letter of Appointment/Acceptance or the Professional Services Contract.
- (2) **Client** means any juristic person or organ of the State engaging a **consulting engineer** for services on a **project**.
- (3) **Construction monitoring** means the process of administering the construction contract and over-seeing and/or inspecting the works, to the extent of the **consulting engineer's** engagement, for the purpose of verification that the works are being completed in accordance with the requirements of the contract that the designs are being correctly interpreted and that appropriate construction techniques are being utilized. **Construction monitoring**, to whatever extent, shall not diminish the **contractor's** responsibility for executing and completing the works in accordance with his contract.
- (4) **Consulting engineer** for purposes of these rules only, means any professional registered in terms of **the Act**, or a juristic person who employs such professional, engaged by a **client** on a **project**.
- (5) **Contractor** means any person or a juristic person under contract to a **client** to perform the **works** or part of it on a **project**, including a subcontractor under contract to such **contractor**.
- (6) **Cost of the works** means the total amount, exclusive of value added tax, certified or which would normally be certifiable for payment to **contractor(s)** (irrespective of who actually carries out the works) in respect of the **works** designed, specified or administered by the **consulting engineer**, before deduction of liquidated damages or penalties, including –
  - a *pro rata* portion of all preliminary and general items applicable to the **works** and

- the costs of new materials, goods or equipment, or a fair evaluation, of such material, goods or equipment as if new whether supplied new or otherwise by, or to, the **client** and including the cost or a fair evaluation of the cost of installation. The sourcing, inspection and testing of such will comprise additional **services** by the **consulting engineer**.
- (7) **Electronic Engineering Services** means **services** related to the provision of electronic systems and detailing the terminations, signals and interconnections of electronic components as distinct from conventional electrical HV, MV and LV systems and related reticulation.
- (8) **Engineering Project** means a project of which the scope comprises mainly engineering work of one discipline only and all financial and administrative matters are dealt with by the **consulting engineer** or where the **consulting engineer** will act as **principal agent** where other disciplines are also involved.
- (9) **Multi-disciplinary Project** means a project comprising building work, together with its associated engineering work, where the engineer is subject to the authority of another professional acting as the Principal Agent while financial and administrative matters are dealt with by another professional.
- (10) **Normal services** means the **services** set out in Clause 3.2.
- (11) **Principal Agent** means the Professional Service Provider appointed as such.
- (12) **Project** means any total scheme envisaged by a **client**, including all the **works** and **services** concerned.
- (13) **Services** means the services contemplated in Clause 3 on a **project** for which a **consulting engineer** is engaged.
- (14) **Stage** means a stage of **normal services** set out in Clause 3.2.
- (15) **The Act** means the Engineering Profession Act, 2000 (Act No. 46 of 2000).
- (16) **Total annual cost of employment** means the total annual cost of employment as defined in Clause 4.4(4).
- (17) **Works** means the activities on a **project** for which **contractor(s)** are under contract to the **client** to perform or are intended to be performed, including the supply of goods and equipment.

## 2.3 SHORT TITLE

This document is called the “2023 NDPW – Scope of Engineering Services and Tariff of Fees”.

## 3. SCOPE OF SERVICES

### 3.1 PLANNING, STUDIES, INVESTIGATIONS AND ASSESSMENTS REPORTS

These services, as indicated below, relate to carrying out studies and investigations as well as the preparation and submission of reports embodying preliminary proposals or initial feasibility studies and will normally be remunerated on a time and cost basis.

- (1) Consultation with the **client** or **client's** authorized representative.
- (2) Inspection of the site of the **project**.
- (3) Preliminary investigation, route location, planning and a level of design appropriate to allow decisions on feasibility.
- (4) Consultation with authorities having rights or powers of sanction as well as consultation with the public and stakeholder groups.
- (5) Advice to the **client** as to regulatory and statutory requirements, including environmental management and the need for surveys, analyses, tests and site or other investigations, as well as approvals, where such are required for the completion of the report, and arranging for these to be carried out at the **client's** expense.
- (6) Searching for, obtaining, investigating and collating available data, drawings and plans relating to the **works**.
- (7) Investigating financial and economic implications relating to the proposals, feasibility studies and/or option analysis and recommendations.
- (8) Clause 3.1(7) does not normally apply to civil and structural **services** on **multi-disciplinary projects**, except as far as the interpretation of cost figures for civil and structural **services** are concerned.

**Deliverables:**

Submission of a report for consideration by the **client**, including all or any of the above, with emphasis on the following:

- Collation of information.
- Reports on technical and financial feasibility and related implications.
- List of consents and approvals.
- Schedule of required surveys, tests, analyses, site and other investigations.
- Comparison of **project** options, including life cycle costing and recommendations where required.

## 3.2 NORMAL SERVICES

These services are applicable to projects where the nature, form and function of the facility has been defined through previous investigations and reports and the engineering services are required to take the **project** through to successful completion of construction.

### 3.2.1 Stage 1 – Inception

(Defined as: Establish **client** requirements and preferences, assess user needs and options, appointment of necessary consultants, and establish the **project** brief including **project** objectives, priorities, constraints, assumptions aspirations and strategies.)

- (1) Assist in developing a clear **project** brief.
- (2) Attend **project** initiation meetings.
- (3) Advise on procurement policy for the **project**.
- (4) Advise on the rights, constraints, consents and approvals.
- (5) Define the scope of **services** and scope of work required.
- (6) Conclude the terms of the **agreement** with the **client**.
- (7) Inspect the site and advise on the necessary surveys, analyses, tests and site or other investigations where such information will be required for **Stage 2** including the availability and location of infrastructure and services.
- (8) Determine the availability of data, drawings and plans relating to the **project**.
- (9) Advise on criteria that could influence the **project** life cycle cost significantly.
- (10) Provide necessary information within the agreed scope of the **project** to other consultants involved.

**Deliverables:**

Submission of a report for consideration by the **client**, including all or any of the above, with emphasis on the following:

- Agreed scope of **services** and scope of work.
- Signed **agreement**.
- Report on **project**, sitd to functional requirements.
- Schedule of required surveys, tests, analyses, site and other investigations.
- Schedule of consents and approvals within related timeframes.

### 3.2.2 Stage 2 – Preliminary Design: Concept and Viability

(Defined as: Prepard to finalise the **project** concept in accordance with the brief, including project scope, scale, character, form and function, plus preliminary programme and viability study/ assessment of the **project**.)

Following the **client's** instructions to proceed with the development of preliminary proposals or the basic planning of the **project**, comprising all or any of the following:

- (1) Agree documentation programme with principal consultant and other consultants involved.
- (2) Attend design and consultants' meetings.

- (3) Establish the concept design criteria.
- (4) Prepare initial concept design and related documentation.
- (5) Advice to the **client** as to the regulatory and statutory requirements, including environmental management and the need for any further surveys, analyses, tests and site or other investigations, as well as approvals, which may be required and arranging for these to be carried out at the **client's** expense. This advice is to be presented by the **consulting engineer** based on the interpretation of the results of these tests and investigations including geotechnical and/or foundation investigations, in a report containing recommendations to be applied to and incorporated in designs. The **consulting engineer** will also take the environmental management plan into account for the full life cycle of the **project**.
- (6) Preparation and submission to the **client** of any preliminary plans, drawings and estimates required for seeking the approval of statutory authorities and the **client**.
- (7) Refine and assess the concept design to ensure conformance with all regulatory requirements and consents.
- (8) Establish access, utilities, services and connections required for the design of the **project**.
- (9) Coordinate design interfaces with other consultants involved.
- (10) Prepare process designs (where required), preliminary designs including preliminary drawings and plans, and related documentation for approval by authorities and **client**, including costing of the aforementioned.
- (11) Provide cost estimates and life cycle costs including financial implications and preliminary programmes.
- (12) Liaise, co-operate and provide necessary information to the **client**, principal consultant and other consultants involved.

#### **Deliverables:**

Submission of a report for consideration by the **client**, including all or any of the above, with emphasis on the following:

- Concept design report.
- Schedule of required surveys, tests and other investigations and related reports.
- Process design report.
- Preliminary design report.
- Cost estimates, concept and viability reports which include all or any of the above.

### **3.2.3 Stage 3 – Detail Design**

(Defined as: Finalise the design, outline specifications, cost plan, financial viability and programme for the **project**.)

- (1) Review documentation programme with principal consultant and other consultants involved.
- (2) Attend design and consultants' meetings.
- (3) Incorporate **client's** and authorities' detailed requirements into the design.
- (4) Incorporate other consultant's designs and requirements into the design.
- (5) Prepare design development drawings including draft technical details and specifications.
- (6) Prepare detail designs, and design drawings including draft technical details and specifications:
  - In the case of reinforced concrete **works**, drawings must include bending schedules.
  - In the case of structural steel **works**, drawings and details provided by the **consulting engineer** must include full information, dimensions and specifications on all sections, connections, plates, fasteners, bolts and welding, to such an extent that no further designs by **contractor(s)** or other parties are required. The **consulting engineer** need not provide shop drawings for the manufacture of the structural steel **works**.
- (7) Review and evaluate design, specifications and estimates of the **cost of works** in order to finalise the detail design **stage**.
- (8) Advice to the **client** on any alternative designs and tenders, but excluding detailed inspection, reviewing and checking of alternative designs and drawings not prepared by the **consulting engineer** and submitted by any **contractor** or potential **contractor**.
- (9) Liaise, co-operate and provide necessary information to the principal consultant and other consultants involved.

- (10) Submit the necessary design documentation to local and other authorities for approval and obtain said approval or alternatively for record purposes where approval is not required by Building Regulations.
- (11) Accommodate services design.

**Deliverables:**

Submission of a report for consideration by the **client**, including all or any of the above, with emphasis on the following:

- Detail design drawings.
- Outline specifications.
- Local and other authority submission drawings, reports and approvals.
- Detailed estimates of construction costs.

### 3.2.4 Stage 4 – Documentation and Procurement

(Defined as: Prepare procurement and construction documentation, confirm and implement the procurement strategies and procedures for effective and timeous procurement of necessary resources for execution of the **project**.)

- (1) Attend design and consultants' meetings.
- (2) Prepare to finalise specifications, schedule of quantities and preambles for the **works**.
- (3) Submission of priced document with a detailed estimate, capital and life cycle costs, financial implications and programmes for implementation of the **works**.
- (4) Reaffirm detailed cost estimates and adjust designs and documents if necessary to remain within approved budget.
- (5) Prepare to finalise the procurement strategy for **contractor(s)** or assist the principal consultant where relevant.
- (6) Prepare documentation for **contractor** procurement.
- (7) Assist in calling for tenders/bids and/or negotiation of prices and/or assist the principal consultant where relevant.
- (8) Liaise, co-operate and provide necessary information to the principal consultant and the other consultants as required.
- (9) Assist in the evaluation of tenders/bids.
- (10) Assist with the preparation of contract documentation for signature.
- (11) Assess samples and products for compliance and design intent.
- (12) Advice to the **client** on any alternative designs and tenders, but excluding detailed inspection, reviewing and checking of alternative designs and drawings not prepared by the **consulting engineer** and submitted by any **contractor** or potential **contractor**.
- (13) Placing orders for the **works** on behalf of the **client**.

**Deliverables:**

Submission of a report for consideration by the **client**, including all or any of the above, with emphasis on the following:

- Finalised Specifications.
- Service co-ordination.
- Detail design drawings.
- Tender/bid documentation.
- Tender/bid evaluation and report.
- Tender/bid recommendation.
- Priced contract documentation.

### 3.2.5 Stage 5 – Contract Administration and Inspection

(Defined as: Manage, administer and monitor the construction contracts and processes including preparation and coordination of procedures and documentation to facilitate practical completion of the **works**.)



- (1) Attend site handover.
- (2) Issue construction documentation in accordance with the documentation schedule including, in the case of structural engineering, reinforcing bending schedules and detailing and specifications of structural steel sections and connections.
- (3) Execute the contract administration in terms of the contract between the **client** and the **contractor**.
- (4) Prepare schedules of predicted cash flow.
- (5) Prepare pro-active estimates of proposed variations for **client** decision making.
- (6) Preparation of and issuing variation orders on behalf of and after consultation with the **client**.
- (7) Attend regular site, technical and progress meetings.
- (8) Inspect **works** for conformity to contract documentation.
- (9) Adjudicate and resolve financial claims by **contractor(s)**.
- (10) Assist in the resolution of contractual claims by the **contractor**.
- (11) Assist the **client** in the resolution of disputes or differences that may arise between the **client** and the **contractor**, except mediation, arbitration and/or litigation.
- (12) Establish and maintain a financial control system.
- (13) Clarify details and descriptions during construction as required.
- (14) Assist and/or prepare valuations for payment certificates to be issued by the **principal agent**.
- (15) Witness and review of all tests and mock ups carried out both on and off site.
- (16) Check and approve **contractor** drawings for design intent.
- (17) Update and issue drawings and drawings register.
- (18) Issue contract instructions as and when required.
- (19) Agreeing and verifying final quantities during construction with the **contractor**.
- (20) Review and comment on operation and maintenance manuals, guarantee certificates and warranties.
- (21) Inspect the **works** and issue practical completion certificates and defects lists.
- (22) Arranging for the delivery of all test certificates, including the Electrical Certificate of Compliance, statutory and other approvals, as built drawings and operating manuals.
- (23) Advice to the **client** on any further alternative designs, but excluding detailed inspection, reviewing and checking of alternative designs and drawings not prepared by the **consulting engineer** and submitted by any **contractor**.

**Deliverables:**

Submission of a report for consideration by the **client**, including all or any of the above, with emphasis on the following:

- Schedules of predicted cash flow.
- Construction documentation.
- Register of drawings issued.
- Estimates for proposed variations.
- Contract instructions.
- Financial control reports.
- Valuations for payment certificates.
- Progressive and draft final account(s).
- Practical completion and defects list.
- All statutory certificates and certificate of compliance as required by the local authorities and by the department.

Where a quantity surveyor is included in the project team in Multi-Disciplinary works, items 4, 5, 9 and 12 will not be required from the engineer.

### 3.2.6 Stage 6 – Close-Out

(Defined as: Fulfil and complete the **project** close-out including necessary documentation to facilitate effective completion, handover and operation of the **project**).

- (1) Inspect and verify the rectification of defects.
- (2) Prepare comments for relevant payment valuations and completion certificates.

- (3) Prepare and/or procure operations and maintenance manuals, guarantees and warranties.
- (4) Prepare and/or procure as-built drawings and documentation.
- (5) Agreeing final quantities with **contractor(s)**, compiling final accounts and issuing final payment certificates.

**Deliverables:**

- Valuations for payment certificates.
- Works and final completion lists.
- Operations and maintenance manuals, guarantees and warranties.
- As-built drawings and documentation.
- Final accounts.

### 3.2.7 Targeted (Preferential) Procurement

Should the **client** during any **stage** of the **project**, require the **consulting engineer** to perform work or **services** pertaining to targeted procurement, such work and or **services** could entail, but are not limited to, any or all of the following:

- (1) incorporation of any targeted (preferential) participation goals;
- (2) the measuring of key participation indicators;
- (3) the selection, appointment and administration of participation and;
- (4) auditing compliance to the above by any **contractor s** and/or professional consultant.

## 3.3 ADDITIONAL SERVICES

The following **services** are additional to the **normal services** provided by the **consulting engineer**, unless specifically agreed otherwise between the **consulting engineer** and the **client**. The **agreement** on the scope of **services** and remuneration shall be in writing and should, if at all possible, be concluded before such **services** are rendered.

### 3.3.1 Additional Services pertaining to all Stages of the Project

- (1) Enquiries not directly concerned with the **works** and its subsequent utilisation.
- (2) Valuation for purchase, sale or leasing of plant, equipment, material, systems, land or buildings or arranging for such valuation.
- (3) Making arrangements for way leaves, servitudes or expropriations.
- (4) Negotiating and arranging for the provision or diversion of services not forming part of the **works**.
- (5) Additional work in obtaining the formal approval of the appropriate Government Departments or Public Authorities, including the making of such revisions as may be required as a result of decisions of such Departments or Authorities arising out of changes in policy, undue delay, or other causes beyond the **consulting engineer's** control.
- (6) Topographical and environmental surveys, analyses, tests and site or foundation or other investigations, model tests, laboratory tests and analyses carried out or procured on behalf of the **client**.
- (7) Setting out or staking out the **works** and indicating any boundary beacons and other reference marks.
- (8) Preparation of drawings for manufacture and installation or detailed checking of such for erection or installation fit.
- (9) Detailed inspection, reviewing and checking of designs and drawings not prepared by the **consulting engineer** and submitted by any **contractor** or potential **contractor** as alternative to those embodied in tender or similar documents prepared by the **consulting engineer**.
- (10) Preparing and setting out particulars and calculations in a special form required by any relevant authority.
- (11) Abnormal additional **services** by or costs to the **consulting engineer** due to the failure of a **contractor** or others to perform their required duties adequately and on time.
- (12) Executing or arranging for the periodic monitoring and adjustment of the **works**, after final handover and completion of construction and commissioning, in order to optimise or maintain proper functioning of any process or system.

- (13) Investigating or reporting on tariffs or charges leviable by or to the **client**.
- (14) Advance ordering or reservation of materials and obtaining licenses and permit.
- (15) Additional **services**, duties and/or work resulting from project scope changes, alterations and/or instructions by the **client**, or his duly authorized agents, requiring the **consulting engineer** to advise upon, review, adapt and/or alter his completed designs and/or any other documentation and/or change the scope of his **services** and/or duties. Such additional **services** are subject to **agreement** in writing between the **consulting engineer** and the **client** prior to the execution thereof.
- (16) Exceptional arrangements, communication, facilitation and agreements with any stakeholders other than the **client** and **contractor(s)** appointed for the **works** on which the **consulting engineer** provides **services**.
- (17) Any other additional **services**, of whatever nature, specifically agreed to in writing between the **consulting engineer** and the **client** prior to the execution thereof.

### 3.3.2 Construction Monitoring

- (1) If the **construction monitoring**, as set out in Clause 3.2.5(3), is deemed to be insufficient by the **consulting engineer**, the **consulting engineer** may, with prior written approval having been obtained from the **client**, appoint or make available additional staff for such **construction monitoring** as are necessary to undertake additional **construction monitoring** on site to the extent specifically defined and agreed with the **client**. The functions in respect of additional **construction monitoring** are to be limited to detailed inspections and exclude those mentioned under Clause 3.2.5.

Applications for additional staff must be made on the department's prescribed format, together with which the **consulting engineer** must submit a proper motivation, containing *inter alia*, a schedule indicating the envisaged time to be spent on additional **construction monitoring** as applied for, as well as the envisaged time to be spent on normal **construction monitoring** as set out in Clause 3.2.5(3).

- (2) Alternatively, the **client** may appoint or make available staff, as intended in Clause 3.3.2(1), subject to approval by the **consulting engineer**.
- (3) Staff, as intended in Clauses 3.3.2(1) and 3.3.2(2), shall report to and take instructions from the **consulting engineer** or an authorized representative of the **consulting engineer** only and shall be deemed to be in the employ of the **consulting engineer**.
- (4) Should any change regarding the persons utilized for additional on-site monitoring or their remuneration or duration of services be necessary, the utilization of such persons and/or their remuneration must be agreed to in writing with the **client** prior to the implementation thereof.
- (5) If, for any reason, no additional staff or inadequate staff for **construction monitoring** is appointed, the **consulting engineer** shall provide additional **services**, including additional site visits, as required and agreed to in writing with the **client** prior to commencement thereof.
- (6) Where provided for in the **agreement**, the duties of the **consulting engineer** for the following defined levels of **construction monitoring**, respectively, are as follows:

(a) **Level 1:**

The **construction monitoring** staff shall:-

- (i) Maintain a part-time presence on site as agreed with the **client** to review random samples and review important completed work prior to enclosure or on completion as appropriate.
- (ii) Where the **consulting engineer** is the sole consultant or **principal agent**, carry out such administration of the **project** as is necessary on behalf of the **client**.
- (iii) Where the **principal agent**, other than the **consulting engineer**, has been appointed for the **project**, provide such information as to enable the **principal agent** to fulfil his responsibilities.
- (iv) Be available to provide the **contractor** with technical interpretation of the plans and specifications.

(b) **Level 2:**

The **construction monitoring** staff shall:-

- (i) Maintain a full time presence on site to constantly review –
  - (a) Work procedures
  - (b) Construction materialsfor compliance with the requirements of the plans and specifications and review completed work prior to enclosure or on completion as appropriate.
- (ii) Where the **consulting engineer** is the sole consultant or **principal agent**, carry out such administration of the **project** as is necessary on behalf of the **client**.
- (iii) Where the **principal agent**, other than the **consulting engineer** has been appointed for the **project**, provide such information as to enable the **principal agent** to fulfil his responsibilities.
- (iv) Be available to provide the **contractor** with technical interpretation of the plans and specifications.

### 3.3.3 Occupational Health and Safety Act, 1993 (Act No.85 of 1993)

Should the **client** require the **consulting engineer** to undertake duties falling under the Occupational Health and Safety Act, 1993 (Act No.85 of 1993) and the Construction Regulations in terms thereof, on behalf of the **client**, the additional **services** may include the following:

- (1) The **consulting engineer** must arrange, formally and in writing, for the **contractor** to provide documentary evidence of compliance with all the requirements of the Occupational Health and Safety Act, 1993 (Act No.85 of 1993).
- (2) The **consulting engineer** must execute the duties of the **client**, as his appointed agent, as contemplated in the Construction Regulations to the Occupational Health and Safety Act, 1993 (Act No.85 of 1993).

### 3.3.4 Quality Assurance System

Where the **client** requires that a quality management system or quality assurance services, over and above **construction monitoring** services, be applied to the **project**, these are in addition to **normal services** provided by the **consulting engineer** and to be specifically defined and separately agreed in writing prior to commencement thereof.

### 3.3.5 Lead Consulting Engineer

Should the **client** require the **consulting engineer** to assume the leadership of a joint venture, consortium or team of consulting engineers, of the same discipline, prescribed or requested by the **client**, the additional **services** may include the following:

- (1) Responsibility for the overall administration of all sections of the **services**, including those portions of the **services**, which fall within the ambit of the other consulting engineers.
- (2) Responsibility for the overall co-ordination, programming of design and financial control of all the **works** included in the **services**.
- (3) Processing certificates or recommendations for payment of **contractor(s)**.

### 3.3.6 Principal Agent of the Client

When a **consulting engineer** is, in addition to his normal functions as **consulting engineer**, appointed as the **principal agent** of the **client** on a project, the **consulting engineer** will also be responsible for the following:

- (1) Leadership of the professional team.
- (2) Submission of preliminary and developed proposals in the form of consolidated reports, drawings and specifications together with estimates of time required and **cost of the works**.

- (3) The overall administration of all sections of the **project** including those, which fall within the ambit of the other professional members in the team.
- (4) The overall coordination, programming of design and financial control of the **project**.
- (5) Resolving differences that may arise between the **client** and the **contractor(s)**, excluding mediation, arbitration or litigation.
- (6) Approval of certificates for payment to **contractor(s)** issued by the other professional members in the team before their presentation to the **client** for settlement.
- (7) Making arrangements to provide the **client**, on completion of the **works**, with such record drawings as may be required for a proper record of the **works** as constructed and such manuals as may be required for the operation and maintenance of the relevant parts of the **works**.
- (8) Approval of the final contract account and provision of a close out report for the **project**.
- (9) Manage targeted procurement **services** as indicated in Clause 3.2.7.

### 3.3.7 Mediation, Arbitration and Litigation proceedings and similar Services

Where the **client** requires the **consulting engineer** to, on his behalf, perform the **services** listed hereunder or similar work, the extent thereof and remuneration therefore is subject to agreement between the **client** and the **consulting engineer**:

- (1) Dealing with matters of law, obtaining parliamentary or other statutory approval, licenses or permits.
- (2) Assisting with or participating in contemplated or actual mediation, arbitration or litigation proceedings.
- (3) Officiating at or attending courts and commissions of enquiry, select committees and similar bodies convened by statute, regulation or decree.

## 4. TARIFF OF FEES

### 4.1 APPLICATION OF TARIFF OF FEES

- (1) The tariff of fees contained in this Schedule applies in respect of the **services** set out in Clause 3 "Scope of Services".
- (2) The **client** shall remunerate the **consulting engineer**, for the **services** rendered, on the basis of Clauses 4.2 and 4.5. In cases where the **client** and **consulting engineer** have agreed that Clauses 4.2 and 4.3 are not applicable, payment should be on the basis of Clause 4.4 or as agreed according to Clause 4.1(4).
- (3) The **client** shall reimburse the **consulting engineer** for all expenses and costs incurred in terms of Clause 4.5 in performing his **services**, irrespective of whether fees are charged in terms of Clauses 4.2 and 4.3 or Clause 4.4 as well as for all costs incurred on behalf, and with the approval of the **client**.
- (4) While the tariff of fees contained in this document can be applied to many projects the factors that influence the fees to be paid for **services** are complex and depend on a number of contributing factors. These contributing factors that should be taken into account may include, inter alia, all or any of the following:
  - (a) **Project complexity:** Projects may range from relatively simple projects where it is based on well established, common practices to more complex projects where it calls for the application of new, unusual or untried practices.
  - (b) **Cost of the works:** This may range from a situation where the **cost of the works** is abnormally high relative to the **services** being rendered to a project where the **cost of the works** is abnormally low relative to the **services** required from the **consulting engineer**.
  - (c) **Time duration:** This may involve projects where the **works** are executed over appreciably shorter or longer periods than would normally be expected for any of the **stages** defined in 3 "Scope of Services".



- (d) **Level of responsibility, liability and risk:** These may range from relatively low levels of responsibility and/or risks to projects with unusually high responsibilities and/or risks that are expected to be carried by the **consulting engineer**.
  - (e) **Level of expertise, qualifications, skills and experience:** Some works do not require a high degree of expertise while other works may require more specialized expertise or substantial skills and experience that cost more to develop and retain.
  - (f) **Level of technology** required and changes in technology that may influence the costs of the **services** provided.
  - (g) Whether aspects related to labour intensive works need to be considered in the design.
- (5) Combinations of one or more of the above factors may require an adjustment of the tariffs to fairly compensate the **consulting engineer** and this adjustment should be negotiated in good faith by both parties.
- (6) Agreement on any adjustment of or special fees should be reached at the time of the engagement of the **consulting engineer** or as soon after circumstances warrant such as practically possible, but in all cases prior to the **consulting engineer** rendering **services** which may be affected.
- (7) Where the **normal services** relate to more than one of the disciplines of consulting engineering contemplated in Clauses 4.2.1 to 4.2.7 namely civil, structural, mechanical, electrical and **electronic engineering services**, a separate fee for **services** in each discipline should be calculated in accordance with the relevant Clause. Where a **consulting engineer** is appointed for either or both electronic and electrical services, his payment shall be according to the electrical Tariff of Fees based on the combined value of these **services**.
- (8) Where at the instance and with the consent of the **client** the **works** are undertaken on separate non-contiguous sites, continuity is interrupted or are unusually fragmented or are constructed as separately documented phases or sections, the fee for **normal services** is:
- (a) The sum of the fees calculated separately for each site, contract, phase or section as if they were separate works; or
  - (b) A fee agreed to between the **client** and the **consulting engineer** and which fee lies between the fee calculated on the total **cost of the works** and the sum of the fees contemplated in Clause 4.1(8)(a) above.
- (9) For the calculation of fees, "duplication of works" is defined as the re-use of designs, drawings and details done by a consultant to duplicate a complete unit (e.g. a building or bridge).
- (10) The following fees may be claimed after each **stage** of **services** or monthly or as agreed between the **consulting engineer** and the **client**:
- (a) Percentage fees determined on the basis of the **cost of the works** prevailing at the time of the fee calculation and *pro rata* to the completed **services**, or a portion of the total fee based on completion of the **stages** along the lines indicated in 4.2.8.
  - (b) Time-based fees applicable when the **services** were rendered.
- (11) Disbursements as set out in Clause 4.1(3) may be claimed monthly.

## 4.2 Fees for Normal Services

### 4.2.1 Civil and Structural Engineering Services pertaining to Engineering Projects

- (1) The basic fee for **normal services** in the disciplines of civil and structural engineering, pertaining to **engineering projects**, is determined from the table below. The fee is the sum of the primary fee and the secondary fee applicable to the specific **cost of the works** in respect of which the **services** were rendered on the **project**.

- (2) The following additional fee shall be applicable to the value of the reinforced concrete and structural steel portions of the **works**, inclusive of the costs of concrete, reinforcing, formwork, structural steel work and any *pro rata* preliminary and general amounts. Where structures of identical design are repeated on the same **project**, the combined costs shall be cumulated for the determination of the cost of the reinforced concrete and structural steel works.

- (3) To calculate the fee for railway track work in terms of this item, 50 per cent of the cost of the permanent way materials is excluded from the **cost of the works**, but the full cost of ballast and equipment specially designed by the **consultant** is included in the **cost of the works**.
- (4) For **normal services** relating to a description of the **works** mentioned in the first column of the following table, the proportion of the basic fee relating to the specific item calculated in terms of Clause 4.2.1(1) and 4.2.1(2) is multiplied by the category factor mentioned against that description in the second column of the table. In case more than one of the descriptions below applies, the effective factor will be the product of the factors involved, except for the fee for targeted procurement.
- (5) These factors do not apply when fees are a lump sum or on a time basis.



- (6) In the case of road works, where the road traverses both rural and urban areas, an adjustment *pro rata* to the length of road in rural and urban area should be made.
- (7) In the case of road rehabilitation, a combination of factors applies depending on the situation of the road (rural or urban) and the category factor for alterations to existing works.

- (2) Where not all the **stages** of the **normal services** are provided by the **consulting engineer**, the fee is, subject to Clause 4.1(7), calculated as a percentage of the total fee calculated in terms of

this Clause, which percentage is the sum of the percentage points appropriate to each **stage** as set out in the above table against those **stages** of the **services** provided by the **consulting engineer**.

#### 4.2.9 Cancellation or Abandonment

Should instructions having been given by the **client** to the **consulting engineer** to proceed with any of the **stages** of **services** set out in Clause 4.2.8(1) and the whole or part of the **works** is cancelled or abandoned or postponed payments will be according to the stipulations of this **agreement** (C2.1.3.8.2 ) Pricing Assumptions in this tender document).

### 4.3 FEES FOR ADDITIONAL SERVICES

- (1) Subject to Clauses 4.2.8(2), 4.3(2), 4.3(3), 4.3(4), 4.3(5), 4.3(6) and 4.3(7), the fees for additional **services**, contemplated in Clause 2.2, are agreed to between the **client** and the **consulting engineer** as set out in Clause 4.1.
- (2) For additional **services** as a result of the resumption of such **services** or the alteration or modification of designs on the instructions of the **client**, the **consulting engineer** is entitled to time-based fees and actual costs incurred.
- (3) For the provision of a **construction monitoring** service, as contemplated in Clause 3.3.2, the **consulting engineer** is entitled to recover from the **client** the fees as agreed between the **consulting engineer** and the **client**:
  - (a) for part time **construction monitoring** staff costs, the amount payable to such staff shall be at the hourly rates contemplated in Clause 4.4(3);
  - (b) for full time **construction monitoring** service the fee shall be based on the **total annual cost of employment** plus a surcharge of twelve percentage points (12%);
  - (c) a maximum of 50 hours may be applied for part time **construction monitoring** per month. Time spent on site in excess hereof will be without further remuneration; and
  - (d) distances for travelling applied for may not be exceeded without prior written approval of the Departmental Project Manager (T1.1.4). Remuneration of travelling will be calculated according to actual distances per month at the applicable rate of the time of travel.
- (4) For all other costs, as set out in Clause 4.5, the actual expenses incurred.
- (5) For duties under the Occupational Health and Safety Act, 1993 (Act No.85 of 1993), as contemplated in Clause 3.3.3, the **consulting engineer** shall, if so appointed by the **client**, be remunerated on a time and cost basis as agreed with the **client**.
- (6) For assuming the leadership of a joint venture, a consortium or team of consulting engineers, as contemplated in Clause 3.3.5, the fee for the lead **consulting engineer** shall be ten percentage points (10%), which is not an additional fee but is that portion of the fee for **services** rendered by the team, which shall be allocated to the lead **consulting engineer**. The apportionment of the fee to **services** is as stated in Clause 4.2.8(1).
- (7) For **services** as **principal agent** of the **client**, as contemplated in Clause 3.3.6, the **consulting engineer** is entitled to an additional fee calculated at one percentage point (1%) of the total **cost of the works** comprising the **project**. The **consulting engineer** is not entitled to any fees for **principal agent** if he is not explicitly appointed as such.

### 4.4 TIME-BASED FEES

- (1)
  - (a) Time-based fees are all-inclusive fees, including allowances for overhead charges incurred by the **consulting engineer** as part of normal business operations, including the cost of management, as well as payments to administrative, clerical and secretarial staff used to support professional and technical staff in general and not on a specific project only.
  - (b) Time-based fees are calculated by multiplying the hourly rate contemplated in Clause 4.4(3), which is applicable to the **consulting engineer** for professional and any other technical staff employed by the **consulting engineer**, with the actual time spent by such staff in rendering the **services** required by the **client**.
  - (c) Professional and technical staff include all staff performing work directly related to the execution of the **services** the **consulting engineer** is engaged for by the **client** and

excludes all administrative, clerical and secretarial staff used to support professional and technical staff in general and not on a specific project only, but includes the typing of letters, minutes, reports and documents for **projects**.

- (2) To determine the time-based fee rates the professional and technical staff concerned is divided into:-
- (a) **Category A**, in respect of a private consulting practice in engineering, shall mean a top practitioner whose expertise and relevant experience is nationally or internationally recognized and who provides advice at a level of specialization where such advice is recognized as that of an expert.
  - (b) **Category B**, in respect of a private consulting practice in engineering, shall mean a partner, a sole proprietor, a director, or a member who, jointly or severally with other partners, co-directors or co-members, bears the risks of the business or takes full responsibility for the projects and related liabilities of such practice and where his/her level of expertise and relevant experience is commensurate with the position performs work of a conceptual nature in engineering design and development, provides strategic guidance in planning and executing a project and/or carries responsibility for quality management pertaining to a project.
  - (c) **Category C**, in respect of a private consulting practice in engineering, shall mean all salaried professional staff with adequate expertise and relevant experience performing work of an engineering nature and who carry the direct technical responsibility for one or more specific activities related to a project. A person referred to in Category B may also fall in this category if such person performs work of an engineering nature at this level.
  - (d) **Category D**, in respect of a private consulting practice in engineering, shall mean all other salaried technical staff with adequate expertise and relevant experience performing work of an engineering nature with direction and control provided by any person contemplated in *categories A, B or C*.
- (3) The scale of fees on a time basis, on which Value Added Tax is excluded, shall be at the following rates per hour, rounded off to the nearest rand:
- (a) for a person in *category A* and *B*: 18.75 cents for each R100 of the total annual remuneration package (lowest notch) attached to a Director's grading (level 13) in the Public Service;
  - (b) for a person in *category C*: 17,5 cents for each R100 of the total annual remuneration package (lowest notch) attached to a Deputy Director's grading (level 12) in the Public Service;
  - (c) for a person in *category D*: 16,5 cents for each R100 of his/her **total annual cost of employment**; provided that this hourly rate shall not exceed 16,5 cents for each R100 of the total annual remuneration package (lowest notch) attached to an Assistant Director's grading (level 11) in the Public Service.

Hourly rates calculated in terms of (a), (b) and (c) above shall be deemed to include overheads and charges in respect of time expended by clerical personnel, which shall, therefore, not be chargeable separately.

Unless otherwise specifically agreed in writing, remuneration for the time expended by *Category B persons* in terms of (a) above on a project shall be limited to 5 per cent of the total time expended on the **project**. Any time expended by principals in excess of the 5 per cent limit shall be remunerated at the rates determined in (b) or (c) above.

Notwithstanding the above, where work is of such a nature that personnel as described in paragraph (c) above are capable of performing such work, it shall be remunerated at that level and not at the rates described in paragraphs (a) and (b) above, irrespective of who in fact executed the work.

The salaries referred to in (a) to (c) above can change from time to time, which will, therefore, change the rates applicable. These rates will, however, only be adjusted on the first day of each

calendar year irrespective of any changes in salary ranges during the relevant year. The rate as set out in Table 8 of the "Rates for Reimbursable Expenses", as amended from time to time may be used as bases for relevant claims.

- (4) For the purposes of Clause 4.4(3)(c), the **total annual cost of employment** (gross annual remuneration) of a person contemplated in Clause 4.4(2) means the total amount borne by an employer in respect of the employment of such a person per year, calculated at the amounts applicable to such a person at the time of appointment of the person.

## 4.5 Expenses and Costs

All expenses and costs shall be claimed for in accordance with the provisions of the **agreement** subject to the submission of substantiating documentation.
