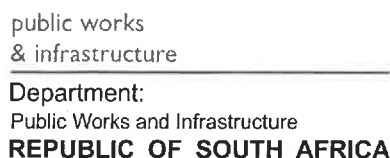

12. Bidders must ensure that PA 32 is duly completed, failure to complete in full will result to elimination.
