 collect oil sample. Properly label the sample with relevant information and store
 it accordingly to laboratory requirements. Send the sample to a qualified
 laboratory for analysis.
- Conduct gas analysis.
- Conduct breakdown voltage.
- Conduct interface tension.
- Conduct furan analysis.
- Conduct polychlorinated biphenyl (PCB) analysis.
- Conduct particle count.
- Conduct Density/Specific gravity test.
- Check and appearance.
- Service and replace cork gaskets on transformers.
- Supply and deliver high quality naphthenic based insulation oil with high dielectric strength and chemical stability with life expectancy of more than 40 years.
- Transformer oil should have good chemical stability when exposed to elevated temperatures which is essential to prevent formation of acidic materials that impair the insulating properties of the oil.
- Transformer oil should carry out its cooling and insulating functions with minimum power requirements when pumped, and to ensure most effective heat removal when circulated by thermal action.
- Transformer oil should comply with the most recent test and standards relating to the effects of corrosive Sulphur and should not contain any inhibitors or passivitors.
