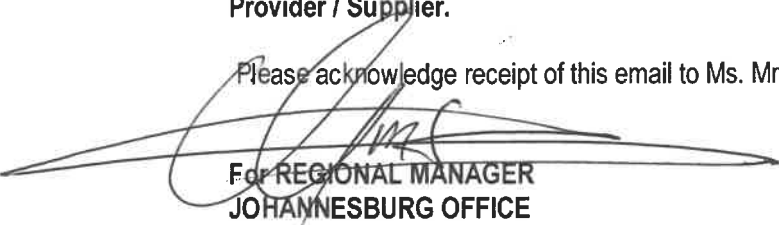

4. POINTS AWARDED FOR SPECIFIC GOALS
