



TERMS OF REFERENCE (TOR) FOR THE EXPANDED PUBLIC WORKS PROGRAMME PROCUREMENT OF BRANDED ALL WEATHER JACKETS, SAFETY BOOTS AND HARD HAT HELMETS.

1. PURPOSE

The purpose of these Terms of Reference (ToR) is to provide clear guidelines for the procurement of branded all weather jackets, safety boots and hard hat helmets for the Expanded Public Works Programme, EPWP participants and brand activation campaigns for stakeholder engagement workshops.

2. BACKGROUND

The Expanded Public Works Programme (EPWP) is one of many Programmes offered by Government to alleviate poverty and provide income relief through short-term to medium-term work opportunities for the poor and unemployed. The EPWP is a nationwide programme coordinated by Department of Public works and Infrastructure (DPWI) implemented by public bodies from all spheres of government (according to their mandates and existing budgets).

3. ASSIGNMENT

The EPWP PR and Communications Directorate is responsible for the procurement of any related branded materials for the Organisation. The branded materials include: the design, layout and printing of publications and marketing materials. The design, layout and printing of publications and marketing materials is guided by the desired specification and quantity required by internal stakeholders.
