



TERMS OF REFERENCE (TOR) FOR THE EXPANDED PUBLIC WORKS
PROGRAMME FOR REMOVAL OF OLD PVC BANNERS, NEW
INSTALLATION OF FULL COLOUR PVC BANNERS, LAYOUT, CREATIVE
DESIGN AND PRINTING OF PVC BANNERS AT DEPT OF PUBLIC WORKS,
CGO AND PWH BUILDING

1. PURPOSE

The purpose of these Terms of Reference (ToR) is to provide clear guidelines for the procurement of removal of old PVC banners, New installation of full colour PVC banners, Layout, Creative design and Printing of PVC banners at Department of Public works and Infrastructure, CGO and PWH Building.

2. BACKGROUND

The Expanded Public Works Programme (EPWP) is one of many Programmes offered by Government to alleviate poverty and provide income relief through short-term to medium-term work opportunities for the poor and unemployed. The EPWP is a nationwide programme coordinated by Department of Public works (DPW) implemented by public bodies from all spheres of government (according to their mandates and existing budgets).

3. ASSIGNMENT

The EPWP PR and Communications Directorate is responsible for the procument of any related branded materials for the Organisation. The branded materials include: the creative design, layout and printing of PVC banners.

The creative design, layout and printing of PVC banners is guided by the desired specification and quantity required by internal stakeholders.

3.1 specifications

Services for the following specifications are required:

- Removal of old PVC Banners, New installation of PVC Banners, Layout,
 Creative Design and Printing of PVC banners in full colour at Deprt of Public works and Infrastructure, CGO and PWH buildings
 - Service provider to provide 4 creative designs
 - Materials: Durable withstand all weather conditions
 - PVC printed in full colour, two logos EPWP and DPWI with pictures and words
 - EPWP Facebook, <u>www.epwp.gov.za</u> and contact details to appear in wall banners
 - Corporate colours: Orange and White.
 - 1. PVC Wall Banners [Installation]

Sizes

- 1.1. 18m x 12m PVC banner with aluminum frame (1 unit) to be installed at PWH building, Bosman Street, PTA
- 1.2. 12m x 9m PVC Banner without a frame (1 unit) to be installed at CGO building, Madiba Street, PTA
- 1.3. 12m x 8,3m PVC Banner to be installed at PWH building, Pretorious Street, PTA
 - Service Provider to provide POE of installlations previously done.
 - N.B: Provide written 18 months guarantee on the materials provided
 - Installation of PVC banners will require roof ropes to remove and install
 - 2. PVC Wall Banners [Removal]
 - 1.1 18m x 12m PVC banner at PWH building, Bosman Street, PTA
 - 1.2 12m x 9m PVC banner at CGO building, Madiba Street, PTA
 - 1.3 12m x 8,3m PWH building, Bosman Street, PTA

The first edition of the EPWP corporate identity manual was produced in 2007, introducing the EPWP logo under the National Department of Public Works, together with the sector lead departments (Department of Social Development, Department of Environmental Affairs and Department of Cooperative Governance and Traditional Affairs).

4. EXPERTISE OF THE SERVICE PROVIDER

The assignment shall be carried out by a service provider with the following competencies:

- Previous track record of supplying marketing materials.
- Sample of previous printed or embroided apparel supplied to any government department or Organisation.
- Reference letter from any government department or Organisation.

5. ASSIGNMENT CHAMPION

The assignment will be championed by EPWP PR and Communication Directorate.

6. PROTECTION OF GOVERNMENT INFORMATION

The Service Provider is required to agree and undertake to abide by and adhere to government legislation, regulations and directives dealing with the protection

of government information as if such legislation, regulations and directives were applicable to him/her and that all reasonable steps shall be taken to ensure that
